# FISCAL YEAR 2018-2019 AND FISCAL YEAR 2019-2020 GENERAL COUNSEL CONTRACT VARIANCE

In March 2018, the Board selected Lewis Brisbois Bisgaard & Smith LLP (Lewis Brisbois) to provide general counsel services to the District, and authorized the General Manager to enter into a six-month Professional Services Agreement with the firm for those services. The agreement expires September 30, 2018.

On <u>MOTION</u> by Swan, seconded by Matheis and unanimously carried, THE BOARD AUTHORIZED THE GENERAL MANAGER TO EXECUTE A VARIANCE TO THE PROFESSIONAL SERVICES AGREEMENT WITH LEWIS BRISBOIS BISGAARD & SMITH LLP FOR GENERAL COUNSEL LEGAL SERVICES FOCUSED ON MUNICIPAL LAW, TRANSACTIONAL AND NON-COMPLEX ISSUES, AND RATE-SETTING WITH A TERM OF OCTOBER 1, 2018, TO JUNE 30, 2020, AND A NOT-TO-EXCEED VALUE OF \$1,500,000.

### ZONE A TO RATTLESNAKE RESERVOIR PUMP STATION CONSULTANT SELECTION

Staff is proceeding with the replacement of the existing Zone A to Rattlesnake Reservoir Pump Station as identified in the 2016 Recycled Water Distribution System Analysis. The existing pump station, which delivers recycled water from the Zone A system to the Rattlesnake Reservoir, was constructed in 1976 and is nearing the end of its useful life. In addition to the pump station replacement, the project also includes modifications to the existing dechlorination facility, installation of a new permanent backup power generator, extended sewer facilities to eliminate onsite septic systems currently located at the caretaker house and the park restrooms, new site electrical service, various communications and control system improvements, and demolition of the Northwood Zone A to B pump station, which will be replaced by the Eastwood Zone A to B pump station currently under construction.

Staff received proposals for engineering design services from AECOM, Brown and Caldwell, Lee & Ro, and Stantec. Brown and Caldwell outlined a focused, collaborative approach to completing the preliminary design, which staff believes is the most critical phase to successfully execute the project.

Director Withers reported that this item was reviewed by the Engineering and Operations Committee on September 18, 2018 and that Brown and Caldwell's proposal impressed the Committee.

On <u>MOTION</u> by Swan, seconded by Matheis and unanimously carried, THE BOARD AUTHORIZED THE GENERAL MANAGER TO EXECUTE A PROFESSIONAL SERVICES AGREEMENT WITH BROWN AND CALDWELL IN THE AMOUNT OF \$1,247,625 FOR ENGINEERING DESIGN SERVICES FOR THE ZONE A TO RATTLESNAKE RESERVOIR PUMP STATION, PROJECT 05476.

#### GENERAL MANAGER'S REPORT

General Manager Cook reported on the Regional Board's recent approval of the NPDES Permit which is a great accomplishment that places all of IRWD into Region 8. It also allows the diversion of MWRP's recycled water into the San Diego Creek under certain emergency conditions. Mr. Cook thanked Ms. Fiona Sanchez, Mr. Jose Zepeda, and Mr. Ian Swift for their efforts along with staff from OCSD and OCWD. He additionally thanked Director Swan who assisted with focusing on certain individuals to seek support on this amendment.

Mr. Cook reported that the District was recognized by WateReuse and received an award for its efforts to dual-plumb the first hotel in Irvine with recycled water.

Mr. Cook thanked both Mr. Kevin Burton and Mr. Paul Weghorst for their efforts as Acting General Managers over the last two weeks while on vacation.

#### CONSENT CALENDAR

#### 2018 LEGISLATIVE AND REGULATORY UPDATE

#### SUMMARY:

This report provides an update on the 2017-2018 legislative session and IRWD priorities. As legislation and regulations develop, staff will provide updates and recommendations to the Water Resources Policy and Communications Committee and the Board, as appropriate. Staff recommends that the report be received and filed.

#### BACKGROUND:

During the 2017-2018 legislative session, 3,264 Assembly bills and 1,511 Senate bills were introduced. In the 2018 legislative year, 1,217 were passed and sent to the Governor. Governor Brown had until midnight on September 30, 2018, to sign or veto bills sent to him at the end of session. Overall, in 2018, the 1,016 bills were chaptered and 201 vetoed. Unless a signed bill contained an urgency measure or language delaying its effective date, the bill will take effect on January 1, 2019.

The 2019-2020 legislative session will convene on December 3, 2018. Legislators will have until February to introduce new legislation.

A copy of the 2018 Legislative Matrix is attached as Exhibit "A". Exhibit "B" is the 2018 Legislative Update Report Links to Bill Texts, which contains links to the bills discussed below, unless a separate exhibit is noted.

#### State Budget Update:

#### August Revenue Numbers:

On September 10, 2018, State Controller Betty Yee released her monthly report on the State's finances. She announced that the State took in \$9.98 billion during the month of August. This was \$1.14 billion, or 12.9 percent, more than the revenue assumptions contained in the Fiscal Year 2018-2019 Budget. "For the first two months of the 2018-19 fiscal year, revenues are \$846.0 million, or 5.4 percent, higher than projected in the enacted budget. While corporation tax missed the mark for the month of August, personal income tax (PIT) and sales tax – the other two of the "big three" revenue sources – came in higher than assumed in the enacted budget."

#### 2017-2018 State Legislative Update:

Staff has provided an update on the bills before the Governor at the end of the legislative session and of interest to the District. A summary and a status report on each bill are provided below:

# *AB 1912 (Rodriguez, D-Pomona) — Joint Powers Authority: Public Employees' Retirement Liability:*

Existing law permits two or more public agencies to form a joint powers authority (JPA). A JPA is a separate entity from the public agencies that form it; however, under existing law, the debts, liabilities and obligations of the JPA become the debts, liabilities and obligations of its member agencies unless the agreement governing the JPA states otherwise. AB 1912, authored by Assemblymember Freddie Rodriguez (D-Pomona), would change this with regard to pension liabilities. Specifically, AB 1912 prohibits the agreement governing the JPA from limiting the pension and retirement obligations to the JPA.

The Governor signed AB1912 on September 29, 2018. It will take effect on January 1, 2019.

#### AB 2050 (Caballero, D-Salinas) — Small Water System Authority Action of 2018:

AB 2050, authored by Assemblymember Anna Caballero (D-Salinas), would have created a new category of water agency — a Small System Water Authority — with unique powers to absorb, improve and competently operate currently non-compliant public water systems with either contiguous or non-contiguous boundaries. Small System Water Authorities would consolidate failing small water systems that are voluntarily donated to the Authority to provide technical, managerial and financial capabilities to ensure the provision of safe, clean, affordable, and accessible water and local governance.

The Governor vetoed AB 2050 on September 28, 2018. In his veto message, he stated that while he appreciated the author's intent, the "bill creates an expensive, bureaucratic process and does not address the most significant problem with providing safe drinking water - a stable funding source to pay for ongoing operations and maintenance costs."

Additionally, his veto message commented on funding safe drinking water stating:

"My administration remains committed to a comprehensive solution to address safe drinking water issues based on shared responsibilities between water users and water providers that will not result in ongoing costs to the General Fund. I urge the Legislature and stakeholders to work towards a stable funding solution in 2019."

# *AB 2447 (Reyes, D- San Bernardino) — California Environmental Quality Act: Environmental Justice:*

AB 2447, authored by the Assemblymember Eloise Reyes (D-San Bernardino), would have expanded the requirements of the California Environmental Quality Act (CEQA) for certain projects and provide for an additional process for certain projects located near or in disadvantaged communities. Specifically, the bill would have required that a lead agency that is preparing an Environmental Impact Report to provide individual notice to owners and occupants of property located within a disadvantaged community when the CEQA review involves industrial or equivalent land uses. As amended, the bill would not have applied to "A project undertaken by a public water supplier or public agency for the conveyance, production, storage,

impoundment, or treatment of safe and reliable water, such as recycled water, wastewater, and stormwater, to serve a disadvantaged community."

The Governor vetoed AB 2447 on September 30, 2018. In his veto message, he stated that:

"I believe that the notice and meeting requirements, as outlined in the bill, are too prescriptive. Disadvantaged communities are entitled to clear and adequate notice, but zones of notice and the definition of projects subject to the requirements should be flexibly defined to reflect the vast diversity of our state."

#### AB 2501(Chu, D-Milpitas) — Drinking Water: Consolidation and Extension of Service:

AB 2501, authored by Assemblymember Kaasen Chu (D-Milpitas), amends the consolidation authorities granted to the State Board in SB 88 (2015). SB 88 authorized the State Board to order a water system to take over and consolidate with a public water system or a state small water system that consistently fails to provide an adequate supply of safe drinking water within a disadvantaged community in order to ensure that those communities would no longer receive unsafe drinking water. In addition to the authority granted in SB 88, AB 2501 extends the State Board's consolidation authority. Among other things, it allows the State Board to order a water system to take over, consolidate or provide service where the disadvantaged community is served a domestic well that consistently fails to provide an adequate supply of safe drinking water or where a school is served with unsafe or inadequate water supply.

AB 2501 was signed by the Governor on September 28, 2018. It will take effect on January 1, 2019.

#### SB 998 (Dodd, D-Napa) — Discontinuation of Residential Water Service:

SB 998, authored by Senate Bill Dodd (D-Napa), establishes new statutory provisions governing when a public water system may discontinue water service at a residential property. Among its many provisions, the bill would prohibit a public water system from discontinuing residential water service for nonpayment until a customer has been delinquent for at least 60 days and has been provided adequate notice about their options to avoid discontinuation of their water service. The bill also prohibits, if certain situations exist, the discontinuation of water service. The bills would prohibit the discontinuation of residential water service where all of the following conditions are met:

- The customer, or a tenant of the customer, submits to the water provider certification from a licensed medical professional that that discontinuation of residential service will be life-threatening to, or pose a serious threat to the health and safety of, a resident of the premises where the service is being provided;
- The customer demonstrates that he or she is financially unable to pay their bill within the normal payment period; if any member of the customer's household is a recipient of CalWORKS, CalFresh, general assistance, Medi-Cal, Supplemental Security Income/State Supplementary Payment Program, or California Special Supplemental

Nutrition Program for Women, Infants and Children; or he or she declares that the household's annual income is within 200 percent of the federal poverty level; and

• The customer is willing to enter into an amortization agreement, alternative payment schedule or plan for deferred or reduce payment with respect to the delinquent charges.

Additionally, the bill limits a water provider's ability to discontinue service if the customer is delinquent on a payment required under an amortization agreement, alternative payment schedule or plan for deferred or reduced payment plan. The bill would require that service could not be discontinued until the customer was 60 days delinquent on those charges. SB 998 also limits reconnection fees and interest charges on past due bills.

SB 998 was signed by the Governor on September 28, 2018. It will take effect on January 1, 2019.

SB 1215 (Hertzberg, D-Van Nuys) — Provision of Sewer Service: Disadvantaged Communities:

SB 1215, authored by Senator Hertzberg (D-Van Nuys), expands the Regional Water Quality Control Boards' (regional boards) authority. Specifically, SB 1215 authorizes the regional boards to order a sewer service provider to extend service to a disadvantaged community or where the residents of a disadvantaged community are served by an onsite sewage treatment system (i.e. septic systems) that does not provide adequate sewage service.

SB 1215 was signed by the Governor on September 30, 2018. It will take effect on January 1, 2019.

# ELECTION OF THE INDEPENDENT SPECIAL DISTRICTS OF ORANGE COUNTY 2019-2020 OFFICERS

#### SUMMARY:

Last month, the Independent Special Districts of Orange County (ISDOC) sought candidates to serve as the association's officers and on its Executive Committee for the 2019-2020 term. The deadline for candidate nominations was September 18, 2018. ISDOC received only one nomination for the offices of Second Vice President, Third Vice President and Treasurer, and no nominations for the office of Secretary. Pursuant to the ISDOC bylaws, the one candidate nominated for those offices will serve in those offices for the 2019-2020 term, and a decision on how to fill the office of Secretary will take place within the first 60 days of the 2019-2020 term. For the offices of President and First Vice President, ISDOC received multiple nominations and, as a result, has called an election for those offices. Each ISDOC by October 23, 2018. Staff recommends that Board authorize staff to cast IRWD's ballot in favor of Saundra Jacobs (Santa Margarita Water District) for President and Mark Monin (El Toro Water District) for First Vice President no later than the October 23, 2018, deadline.

#### BACKGROUND:

ISDOC is a membership association of Orange County's 25 independent special districts. Its purpose is to advance the interests of Orange County special districts through advocacy of sound public policy, educational opportunities to enhance special district governance and services, and collaboration with others to elevate awareness of the role of special districts. ISDOC does not have any responsibility for the Orange County Special Districts Selection Committee, which is a separate and unrelated entity.

ISDOC has sought nomination of candidates interested in serving as ISDOC officers and on its Executive Committee for the 2019-2020 term. The ISDOC Executive Committee determines the direction and focus of ISDOC. The Executive Committee is comprised of the ISDOC President, First Vice President, Second Vice President, Third Vice President, Secretary, Treasurer and the Immediate Past President. The responsibilities of each office are as follows:

- <u>*President:*</u> The President is the chief executive officer of ISDOC. He or she presides at all meetings of the Board of Directors and the Executive Committee; appoints all committees; and represents ISDOC as its official spokesperson;
- *First Vice President*: The First Vice President chairs the Program Committee, and in the absence of the President, serves as the President;

- <u>Second Vice President</u>: The Second Vice President chairs the Membership Committee, and in the absence of the President and First Vice President, serves as the President;
- <u>*Third Vice President:*</u> The Third Vice President chairs the Legislative Committee, and in the absence of the President, First Vice President, and Second Vice President, serves as the President;
- <u>Secretary</u>: The Secretary is responsible for all correspondence and the dissemination of information to members. The Secretary prepares and distributes agendas and minutes for the Executive Committee meeting and edits and publishes the quarterly newsletter; and
- <u>*Treasurer*</u>: The Treasurer maintains ISDOC financial records and bank accounts; collects dues and other receipts; and pays all bills duly approved by the Executive Committee.

#### ISDOC Election Process:

#### NEWPORT COAST ZONE 4-2 PRESSURE REGULATING VALVE MODIFICATION CONSTRUCTION AWARD

#### SUMMARY:

The Newport Coast Zone 4-2 Pressure Regulating Valve (PRV) Modification will modify the existing PRV station located on Newport Coast Drive, approximately mid-way between Pelican Hill Road South and Pelican Hill Road North, to serve as a secondary water source for the Coastal Zone 2 Reservoir. Staff recommends that the Board:

- Authorize a budget increase for Project 05410 in the amount of \$41,400, from \$187,100 to \$228,500; and
- Authorize the General Manager to execute a construction contract with Leed Electric, Inc. in the amount of \$129,208 for the Newport Coast Zone 4-2 PRV Modification.

#### **BACKGROUND:**

The Coastal Zone 2 Reservoir was built in 1990, but was removed from service because the development and demand in the area were not sufficient to cycle the reservoir and maintain water quality. With the reservoir offline, Coastal Zone 2 was supplied by the Zone 3R-2 PRV located on Pelican Hill Road South and the Zone 4-2 PRV in Newport Coast Drive. By June 2012, demand driven by ongoing development of the area was sufficient to return the reservoir into operation, and the Zone 3R-2 PRV on Pelican Hill Road South was modified to fill the reservoir. This project will modify the Zone 4-2 PRV located on Newport Coast Drive to fill the reservoir as a second source of supply. The project site is shown in Exhibit "A".

#### Construction Award:

The District's design consultant, Psomas, completed the design in August 2018. Since nearly all the proposed improvements are electrical, the project was advertised to a select bidders list of six electrical contractors: Beard Electric, Halcyon Electric, Johnson-Peltier, Leed Electric, Morrow-Meadows Corporation and Hydrotech Electric. The bid opening was held on September 18, 2018, and only one bid was received from Leed Electric, Inc. in the amount of \$129,208; the engineer's estimate was \$106,500. As an electrical subcontractor, Leed Electric has worked on several District projects, including the East Orange County Water District Interconnection, which was a similar PRV project. The bid summary is attached as Exhibit "B".

The receipt of only one bid on this project may be attributed to several reasons: 1) The PRV vault is a permit-required confined space with access via a manhole located in Newport Coast Drive, requiring workers entering the vault to wear a safety harness that is attached to a tripod located on the street surface. A standby person will be positioned at the tripod, ready to retrieve an entering worker in an emergency scenario; 2) the work hours of 9 a.m. to 3 p.m., as required by the City of Newport Beach, coupled with the requirement that vault-entering workers wear

safety harnesses, will be restrictive to construction activities and production; and 3) the PRV vault is located in the slow northbound lane of Newport Coast Drive and since electrical contractors on District projects do not typically work within the street right of way, they may be disinclined to retain a subcontractor for traffic control. Since the low bid is reasonable and the contractor has proven past experience on District projects, staff recommends awarding the construction contract to Leed Electric, Inc.

## FISCAL IMPACTS:

Project 05410 is included in the FY 2018-19 Capital Budget. A budget increase is required to fund the construction and engineering support services for the project as shown in the table below.

This project is subject to the California Environmental Quality Act (CEQA) and in conformance with California Code of Regulations Title 14, Chapter 3, Article 7, Section 15301, which provides exemption for the operation, repair, maintenance, or minor alteration of existing public or private structures, facilities, mechanical equipment, or topographical features, involving negligible or no expansion of use beyond that existing at the time of the lead agency's determination. A Notice of Exemption was filed with the Orange County Clerk Recorder on June 12, 2018.

#### COMMITTEE STATUS:

Construction awards are not routinely taken to Committee prior to submittal to the Board.



#### ROCKFIELD ZONE 4-3 AUTOMATED VALVE CONSTRUCTION AWARD

#### SUMMARY:

The Rockfield Zone 4-3 Automated Valve project will install a pressure regulating valve (PRV) and flow meter in an existing vault located on Rockfield Boulevard in Irvine to automate the delivery of water from Lake Forest Zone 4 to Irvine Zone 3. Staff recommends that the Board:

- Authorize a budget increase for Project 07750 in the amount of \$409,400, from \$187,100 to \$596,500; and
- Authorize the General Manager to execute a construction contract with Paulus Engineering, Inc. in the amount of \$361,196 for the Rockfield Zone 4-3 Automated Valve.

#### BACKGROUND:

The District receives 6.8 million gallons per day (MGD) of water from the Baker Water Treatment Plant. In the summer months, there is sufficient demand in the Lake Forest service area to use 6.8 MGD. During winter months the demand in the Lake Forest area falls below 6.8 MGD and water from the Baker Water Treatment Plant is wheeled from Lake Forest Zone 4 to Irvine Zone 3 system through a manually operated valve located on Rockfield Boulevard northwest of Lake Forest Drive. The Rockfield Zone 4-3 Automated Valve project will install an automated PRV valve and flow meter in an existing vault located adjacent to the existing manual valve. The project site is shown in Exhibit "A".

#### Construction Award:

In August, the District's design consultant, CivilSource/NV5, completed the design and the project was advertised for construction bidding to a select bidders list of 14 contractors. The bid opening was held on September 25, 2018 with four contractors submitting bids. The apparent low bidder was Paulus Engineering, Inc. with a bid of \$361,196; the other three bids were between \$429,510 and \$452,890. The bid summary is attached as Exhibit "B". The engineer's estimate was low at \$279,000 and did not appropriately reflect the City of Irvine's restrictive work hours of 9 a.m. to 3 p.m. The project will take approximately one month to construct. Based on the contractor's proven experience on previous District projects, staff recommends awarding the construction contract to Paulus Engineering, Inc.

#### FISCAL IMPACTS:

## IRVINE INDUSTRIAL COMPLEX EAST ZONE A TO B PUMP STATION UPGRADES CONSULTANT SELECTION AND CONSTRUCTION AWARD

#### SUMMARY:

The Irvine Industrial Complex (IIC) East Zone A to B Booster Pump Station (BPS) Upgrades project includes installation of a new pump and construction of miscellaneous electrical and mechanical upgrades at the existing pump station. Staff recommends that the Board:

- Authorize the General Manager to execute a Professional Services Agreement in the amount of \$133,750 with Lee & Ro, Inc. for engineering support services during construction; and
- Authorize the General Manager to execute a construction contract with RC Foster Corporation in the amount of \$1,471,500 for the IIC East Zone A to B Pump Station Upgrades project.

#### **BACKGROUND:**

The Recycled Water Distribution System Analysis, prepared by Stantec in March 2016, describes how IRWD's non-potable water distribution system has undergone significant changes in operations, demands, and facility planning over the past several years. The most significant changes to the demands and operation are anticipated within the recycled water system, specifically the Zone B and Zone C pressure zones north of the I-5 freeway.

The existing IIC East Zone A to B BPS, which was constructed in 1990 and is located near the intersection of Irvine Center Drive and Odyssey as shown on Exhibit "A", currently supplies the East Irvine and Quail Hill Zone B service areas. As neighborhood development construction progresses, the pump station will also supply the Great Park Neighborhoods and Northwood Zone B service areas. To accommodate the additional system demands, the pump station capacity needs to be increased.

The project will increase the overall pump station capacity through the installation of an additional pump. During the design phase, staff identified the need for additional improvements at the pump station to replace equipment that has reached the end of its service life. These improvements include replacement of the pump station control panel, motor control center including two new variable frequency drives, and four existing pump motors. With the addition of the new pump, the site electrical service will also be replaced to accommodate the increased electrical load at the facility.

#### Consultant Selection:

Lee & Ro performed all elements of the project design including civil, mechanical, structural, electrical, and instrumentation. Staff requested Lee & Ro to submit a proposal for engineering jm IIC East BPS Consultant Selection and Construction Award.docx

support services during construction. The proposal, which is attached as Exhibit "B", includes services for submittal reviews, responses to contractor questions, site visits, record drawings, energy control procedures, and construction coordination and engineering support commensurate with the requirements of the project.

Staff reviewed Lee & Ro's proposal and recommends that the Board authorize the General Manager to execute a Professional Services Agreement with Lee & Ro in the amount of \$133,750 for engineering support services during construction.

#### Construction Award:

The project was advertised for construction bids on August 28, 2018 to a select list of 12 contractors including ARB, Archer Western Contractors, Cushman Contracting Coproration, Gateway Pacific Contractors, GSE Construction Company, Olsson Construction, Pacific Hydrotech Corporation, Pascal & Ludwig Constructors, RC Foster Corporation, Schuler Constructors, SS Mechanical Corporation, and Stanek Constructors.

The bid opening was held on September 27, 2018 with bids received from Gateway Pacific Contractors, Pacific Hydrotech Corporation, Pascal & Ludwig Constructors, and RC Foster Corporation. RC Foster Corporation is the apparent low bidder with a bid amount of \$1,471,500. The remaining bids ranged from \$1,486,900 to \$1,592,000. The engineer's estimate, prepared by Lee & Ro, was \$1,602,000. The bid summary is attached as Exhibit "C".

Staff reviewed RC Foster Corporation's bid and has determined that it is responsive. Staff recommends that the Board authorize the General Manager to execute a construction contract with RC Foster Corporation in the amount of \$1,471,500.

#### FISCAL IMPACTS:

The IIC East Zone A to B BPS Upgrades project is included in the FY 2018-19 Capital Budget and will be funded 90% through replacement funds and 10% through regional recycled water funds. The existing budgets are sufficient to fund staff's recommendations.

#### ENVIRONMENTAL COMPLIANCE:

This project is exempt from the California Environmental Quality Act (CEQA) as authorized under the California Code of Regulations, Title 14, Chapter 3, Section 15301 which provides exemption for minor alterations of existing public or private structures, facilities, mechanical equipment, or topographical features, involving negligible or no expansion of use beyond that existing at the time of the lead agency's determination, and Section 15303 which provides exclusion for new, small facilities or structures with new small equipment within the facility. A Notice of Exemption for the project was filed with the County of Orange on August 4, 2017. The consultant selection recommendation was reviewed by the Engineering and Operations Committee on September 18, 2018. Construction Awards are not routinely taken to Committee prior to submittal to the Board.

- 1.6 Energy Control Procedure and Asset Management: LEE & RO will prepare ECP's in accordance with California Occupational Safety and Health (Cal/OSHA) requirements for all equipment that may have potential energy on template forms provided by the District. We will also complete IRWD's Asset Management spreadsheet to inventory all of the new equipment for the project. We will submit a draft set of ECPs and Asset Management spreadsheet and finalize these documents after receipt of District review comments. Documents will be submitted in electronic format.
- **1.7** Additional Construction Coordination: Additional construction coordination is intended to cover any items that don't fall specifically into the RFI or submittal

#### AGREEMENT TO COST SHARE EARLY PLANNING ACTIVITIES FOR THE KERN FAN GROUNDWATER STORAGE PROJECT

#### SUMMARY:

In August 2017, IRWD and Rosedale-Rio Bravo Water Storage District (Rosedale) jointly submitted to the California Water Commission (CWC) a grant application for the proposed Kern Fan Groundwater Storage Project. In July 2018, the CWC conditionally awarded \$67.5 million to the project. In order to facilitate the design, construction and operation of the project, IRWD and Rosedale intend to form a Joint Powers Authority (JPA). While the JPA agreement is being developed, staff and legal counsel have prepared an agreement that would require IRWD and Rosedale to cost share early project planning activities. Staff recommends that the Board authorize the General Manager to execute the agreement, subject to substantive changes approved by the Supply Reliability Programs Committee.

#### **BACKGROUND:**

Proposition 1, also known as the Water Quality, Supply and Infrastructure Improvement Act of 2014, dedicated \$2.7 billion for investments in new water storage projects through the Water Storage Investment Program (WSIP). In August 2017, IRWD and Rosedale jointly submitted an application for the proposed Kern Fan Project with a request for \$86 million in WSIP grant funding. This amount equals 50% of the total estimated capital cost of the project. In July 2018, the CWC conditionally awarded \$67.5 million in grant funding to the Kern Fan Project.

In order to secure the funding from the CWC, certain project planning and feasibility related tasks need to be completed by January 2022. In anticipation of fulfilling these requirements and proceeding with the project, IRWD and Rosedale intend to form a JPA. The JPA would carry out functions necessary to implement the Kern Fan Project including land acquisition, environmental review, permitting, planning, design, construction and operations.

## Cost Sharing Agreement for Early Planning Activities:

During the time that the JPA Agreement is being developed and executed, it would be mutually beneficial to initiate certain early planning activities related to the Kern Fan Project. Such early planning activities include property investigations, geophysical investigations, hydraulic evaluations and alignment studies for certain components of the project. Among other benefits, these early planning activities will help to define a stable and finite project description to facilitate preparation of environmental documentation for the project that is consistent with the California Environmental Quality Act. Staff and legal counsel have prepared the cost sharing agreement provided as Exhibit "A", which would require IRWD and Rosedale to share equally in the cost of early project planning activities. Staff recommends that the Board authorize the General Manager to execute the agreement, subject to non-substantive changes or substantive changes approved by the Supply Reliability Programs Committee.

#### FISCAL IMPACTS:

On August 27, 2018, the Board approved the addition of the Kern Fan Groundwater Storage Project, Project 10854, to the Fiscal Year 2018-19 Capital Budget with initial expenditures limited to \$5 million. The CWC will provide \$67.5 million in WSIP funding through a grant agreement. Rosedale and IRWD will split the costs for the balance of the project. The existing authorization limits for IRWD staff approval of expenditures will not be changed by this agreement.

#### ENVIRONMENTAL COMPLIANCE:

A Final EIR for the Stockdale Integrated Banking Project was prepared, certified and approved in compliance with California Environmental Quality Act (CEQA) of 1970 (as amended), codified at California Public Resources Code Sections 21000 et. seq., and the State CEQA Guidelines in the Code of Regulations, Title 14, Division 6, Chapter 3. Rosedale, as lead agency, filed a Notice of Determination for the Stockdale Integrated Banking Project with the County of Kern. IRWD, as a responsible agency, filed Notices of Determination with the County of Orange and with the County of Kern. The EIR includes a program-level analysis of impacts of a third project site. When a third Stockdale project site is identified, subsequent project-level environmental review will be necessary prior to implementation of phase one of the Kern Fan Project. It is expected that a new EIR will be required for the construction and operation of the second phase facilities contemplated in the proposed Kern Fan Project.

#### COMMITTEE STATUS:

This item was reviewed in concept by the Supply Reliability Programs Committee. The attached draft agreement was not reviewed by the Committee due to limited time constraints and the need to proceed with early planning activities.

#### **RECOMMENDATION:**

THAT THE BOARD AUTHORIZE THE GENERAL MANAGER TO EXECUTE THE AGREEMENT BETWEEN ROSEDALE-RIO BRAVO WATER STORAGE DISTRICT AND IRVINE RANCH WATER DISTRICT FOR COST SHARING EARLY PLANNING ACTIVITIES FOR THE KERN FAN GROUNDWATER STORAGE PROJECT, SUBJECT TO NON-SUBSTANTIVE CHANGES OR SUBSTANTIVE CHANGES APPROVED BY THE SUPPLY RELIABILITY PROGRAMS COMMITTEE.

#### Agreement Between Rosedale-Rio Bravo Water Storage District and Irvine Ranch Water District for Cost Sharing Early Planning Activities for the Kern Fan Groundwater Storage Project

Rosedale-Rio Bravo Water Storage District ("Rosedale") and Irvine Ranch Water District ("IRWD") (individually "Party" and collectively "Parties") intend to enter into a Joint Powers Authority ("JPA") Agreement creating the Kern Fan Project Authority ("Authority") to design, construct, operate and administer the Kern Fan Groundwater Storage Project ("Kern Fan Project").

On July 24, 2018, the California Water Commission conditionally approved a Water Storage Investment Program grant for the Kern Fan Project. Following the conditional grant approval, Rosedale and IRWD have determined that it would be mutually beneficial to initiate certain early planning activities related to the Kern Fan Project prior to the execution of the JPA Agreement. The early planning activities include, but are not necessarily limited to, property investigation, geophysical investigation, a hydraulic evaluation, and alignment evaluations for certain components of the proposed project.

Rosedale and IRWD agree to equally share the cost of the agreed-upon early planning activities including all technical studies necessary to support the Kern Fan Project planning. It is anticipated that Rosedale and IRWD each will separately enter into agreements with consultants to perform the planning activities. Prior to entering into a professional services agreement with a consultant, Rosedale and IRWD each will submit to the other Party the respective consultant's proposal, including scope of work, rates, total cost, and schedule. Any consultant work change orders shall be submitted to the other Party.

The consultant work cost shall be subject to cost-sharing under this Agreement if the General Manager of Rosedale, or his designee, and the General Manager of IRWD, or his designee, each approve the same consultant work cost, including any change orders, in a writing delivered to the other Party (e.g., by letter or electronic mail). Consultant work costs incurred after July 24, 2018, but prior to the effective date of this Agreement are subject to cost-sharing under this Agreement only so long as the General Manager of Rosedale, or his designee, and the General Manager of IRWD, or his designee, each approve the same consultant work cost in a writing delivered to the other Party (e.g., by letter or electronic mail). Each Party's cost share approval of any consultant scope of work and associated costs shall be subject to the limits of signatory authority of the Party's General Manager, or his designee or as otherwise approved by the Party's Board of Directors.

Rosedale and IRWD each agree to pay their respective consultants directly and to provide consultant invoices to the other Party for purposes of implementing the equal cost-sharing under this Agreement. Upon completion of the consultant work, Rosedale and IRWD shall each deliver to the other documentation of the work performed and to present an invoice with supporting detail and backup for reimbursement of one-half of the cost incurred for the services provided. Payment of the invoices shall be due and payable within forty-five (45) days of presentation of each invoice with supporting detail and backup. For any approved early planning activities

consultant work that continues after formation of the Authority, Rosedale and IRWD agree to equally share the costs of such approved work through the Authority. To that end, Rosedale and IRWD anticipate the Authority will assume their respective consultant contracts for early planning activities.

Rosedale and IRWD anticipate that the standard costs for their respective staff time, the costs for their respective outside counsel, and their costs for other professional services administering early planning activities will be reimbursed by the Authority after its formation. Rosedale and IRWD agree that each Party shall account for its respective staff time, outside counsel costs, and any other professional services administering early planning activities prior to formation of the Authority. Rosedale and IRWD anticipate that reimbursement for their respective staff time, outside counsel costs and any other professional services after Authority formation will be governed by the JPA Agreement and any administrative services agreement formed between the Authority, on one hand, and Rosedale or IRWD, on the other hand.

This Agreement shall be effective as of the date last executed by Rosedale or IRWD.

This Agreement may be executed in counterparts.
