IRWD 2018 SEWER SYSTEM MANAGEMENT PLAN

General Manager Cook reported that the State Water Resources Control Board is the permitting agency for sewage collection systems in California and requires that the owner of a sewage collection system develop, implement, and update a Sewer System Management Plan (SSMP). Mr. Cook said that as part of the SSMP implementation, the State Board also requires that the governing body of the agency that owns the sewer system certify the SSMP.

Director Withers reported that this item was reviewed by the Engineering and Operations Committee on August 20, 2018. On <u>MOTION</u> by Withers, seconded and unanimously carried, THE BOARD APPROVED AND CERTIFIED THE IRWD 2018 SEWER SYSTEM MANAGEMENT PLAN.

ADDITION OF THE KERN FAN GROUNDWATER STORAGE PROJECT TO THE FISCAL YEAR 2018-19 CAPITAL BUDGET

Using a PowerPoint presentation, Director of Water Resources Sanchez provided an overview of the Kern Fan project. Ms. Sanchez reviewed the project purpose to develop a regional water bank in the Kern Fan area to capture, recharge and store unallocated Article 21 water from the State Water Project (SWP) during wet hydrologic periods. The stored water would be extracted when needed to provide ecosystem, emergency supply and water supply benefits. Project operations would be coordinated with the SWP through an agreement with the California Department of Water Resources.

Ms. Sanchez reviewed the project elements noting that new conveyance from the California aqueduct would include a new turnout, a 10-mile canal, 500 cfs capacity, three lift stations, 1,050 acres of recharge basins, and 12 recovery wells. She reviewed a potential location of the proposed project facilities, project benefits, project funding, and schedule. She further reviewed the next steps which include: 1) develop and execute Joint Powers Authority (JPA) agreements with Rosedale-Rio Bravo Water Storage District; 2) develop and execute JPA bylaws; 3) identify canal alignment(s) and evaluate properties for purchase; 4) meet additional requirements specified in Water Storage Investment Program regulations by January 1, 2022; 5) execute funding agreement once additional requirements are met; and 6) continue to investigate potential federal funding sources.

Director Swan reported that this item was reviewed by the Supply Reliability Programs Committee on August 16, 2018. Following discussion, on <u>MOTION</u> by Swan, seconded and unanimously carried, THE BOARD AUTHORIZED THE ADDITION OF THE KERN FAN GROUNDWATER STORAGE PROJECT, PROJECT 10854, IN THE AMOUNT OF \$185,976,000, TO THE FISCAL YEAR 2018-19 CAPITAL BUDGET, LIMITING IRWD'S INITIAL EXPENDITURES AT \$5,000,000.

PRESENTATION

TROPICAL PLAZA NURSERY'S ORANGE COUNTY GREEN AWARD AND 2018 HUMANITARIAN AWARD FOR A DONATED SUCCULENT GARDEN AT IRWD'S BAKER WATER TREATMENT PLANT

Mr. Victor Zamora of Tropical Plaza Nursery presented to the Board a duplicate of its California Landscape Contractors' Association Orange County Green Award and a 2018 Humanitarian Award for its donation of the succulent garden at the Baker Water Treatment Plant. Mr. Zamora thanked both Mr. Thomas Bonkowski and Mr. David Asman for the great working relationship with him during this project as well as past projects.

LAGUNA CANYON ROAD AND QUAIL HILL PARKWAY CATHODIC PROTECTION CONSTRUCTION AWARD

This project will construct a new cathodic protection system for the domestic and recycled water pipelines to reduce the potential for future corrosion leaks. The affected recycled water segments include an approximately 8,200-foot segment, located on Laguna Canyon Road between Barranca Parkway and Romano, and an approximately 5,300-foot segment, located on Quail Hill Parkway between Laguna Canyon Road and Shady Canyon Road. A parallel 3,700-foot, 16-inch to 20-inch steel domestic water segment, located on Quail Hill Parkway between East Knoll Crest and Shady Canyon Road, was also included to prevent the negative impacts of stray current and protect it as well.

The project was advertised for construction bidding to a select list of six cathodic protection contractors. Corrpro Companies, Inc. is the apparent low bidder with a bid amount of \$1,085,918.98; the engineer's estimate was \$1,171,080. On <u>MOTION</u> by LaMar, seconded and unanimously carried, THE BOARD AUTHORIZED A BUDGET INCREASE FOR PROJECT 05156 IN THE AMOUNT OF \$275,000, FROM \$588,500 TO \$863,500, AND FOR PROJECT 10541 IN THE AMOUNT OF \$50,000, FROM \$491,700 TO \$541,700; AND AUTHORIZED THE GENERAL MANAGER TO EXECUTE A CONSTRUCTION CONTRACT WITH CORRPRO COMPANIES, INC. IN THE AMOUNT OF \$1,085,918.98 FOR THE LAGUNA CANYON ROAD AND QUAIL HILL PARKWAY CATHODIC PROTECTION, PROJECTS 05156 AND 10541.

POWER PURCHASE AGREEMENT FOR BAKER SOLAR PROJECT

Using a PowerPoint presentation, Engineer Bennett reported that the Baker Solar Project is a proposed 1.1 megawatt (mW) photovoltaic (PV) facility to be constructed adjacent to the Baker Water Treatment Plant. The Project will supplement electricity provided by Southern California Edison to IRWD and will operate in conjunction with an energy storage system to reduce IRWD's cost of electricity at the Baker Plant.

Mr. Bennett said that staff, in conjunction with special legal counsel, evaluated the following three options for implementing the Project: Option 1 - Long term lease under a Power Purchase Agreement (PPA) with SunPower; Option 2 - Ownership by IRWD through an agreement with SunPower; and Option 3 - Ownership by IRWD through an agreement with a third-party solar contractor. Using charts and graphs, Mr. Bennett reviewed an economic analysis of ownership options. He further reviewed the proposed schedule for the project.

Director Withers reported that this item was reviewed by the Engineering and Operations Committee on August 20, 2018. General Manager Cook said that he would like to include language on the lease where the leased area is limited to only the area comprising the top of the reservoirs where the panels will be placed. Following discussion, on <u>MOTION</u> by Withers, seconded and unanimously carried, SUBJECT TO NON-SUBSTANTIVE CHANGES, THE BOARD AUTHORIZED THE GENERAL MANAGER TO EXECUTE A POWER PURCHASE AGREEMENT WITH SOLAR STAR IRWD BAKER, LLC TO OWN, DESIGN, CONSTRUCT, OPERATE AND MAINTAIN A PHOTOVOLTAIC SYSTEM AT THE BAKER WATER TREATMENT PLANT WITH LANGUAGE TO BE INCORPORATED STATING THAT LEASED AREA IS LIMITED TO ONLY THE AREA THAT COMPRISES THE TOP OF THE RESERVOIRS FOR AN AMOUNT OF SPACE REQUIRED FOR THE PANELS AND OTHER EQUIPMENT AS DETERMINED BY STAFF.

GENERAL MANAGER'S REPORT

General Manager Cook reported that he and staff will be meeting with the Bureau of Reclamation tomorrow in Sacramento relative to Federal issues.

He further said that he will be on vacation for two weeks beginning September 7, 2018 and that Mr. Kevin Burton will be Acting General Manager the week of September 10 and Mr. Paul Weghorst will be Acting General Manager the week of September 17.

DIRECTORS' COMMENTS

Director Withers reported that Mr. Bob Ghirelli, Assistant General Manager of the Orange County Sanitation District, has retired.

Director Swan reported that he attended an OCWD Board meeting, Newport Chamber of Commerce meetings, a WACO Planning meeting, and an Urban Water Institute conference, and that tomorrow he will be in Sacramento attending an ACWA Energy conference.

Director LaMar reported that he attended an Urban Water Institute conference.

Director Reinhart also reported on his attendance at an Urban Water Institute conference.

Consultant Bruce Newell reported on the Holy Jim fire which he said burned 150 acres today. He said that he will be attending a community fire meeting on September 13th.

2018 LEGISLATIVE AND REGULATORY UPDATE

SUMMARY:

This report provides an update on the 2017-2018 legislative session and IRWD priorities. As legislation and regulations develop, staff will provide updates and recommendations to the Water Resources Policy and Communications Committee and the Board, as appropriate. Staff recommends that the report be received and filed.

BACKGROUND:

The Legislature returned from its Summer Recess on August 6, 2018. August 31 was the last day of the 2017-2018 regular legislative session and the last day for the Legislature to act on regular session bills before the Final Recess. The Governor has until September 30 to sign or veto legislation passed by the Legislature this year. The 2019-2020 Regular Legislative Session will begin on December 3, 2018, when newly-elected members are sworn in.

A copy of the 2018 Legislative Matrix is attached as Exhibit "A". Exhibit "B" is the 2018 Legislative Update Report Links to Bill Texts, which contains links to the bills discussed below, unless a separate exhibit is noted.

State Budget Update:

July Revenue Numbers:

On August 10, 2018, State Controller Betty Yee released her monthly report on the State's finances. She announced that the State took in \$6.63 billion during the month of July. This was \$294.7 million, or 4.3 percent, less than the revenue assumptions contained in the Fiscal Year 2018-2019 Budget. The lower-than-anticipated revenues were due to sales tax revenues coming in at \$818.4 million, which was \$659.1 million or 44.6 percent less than expected. Personal income tax revenues and corporate tax revenues both came in higher than expected.

Except for the lower revenues, "the state's General Fund had a positive cash balance of \$5.54 billion. Receipts were \$3.62 billion less than disbursements in July, which left a cash balance of \$1.92 billion at the end of the month. There was no internal borrowing" according to the State Controller's report.

2017-2018 State Legislative Update:

As has been traditionally done after the legislative session has recessed, staff has provided an update on the bills active at the end of the legislative session and of interest to the District. A summary and a status report on each bill are provided below:

Proposed Water Tax or Voluntary Remittance for Safe and Affordable Drinking Water:

In 2017, Senator Bill Monning (D-Santa Cruz) authored SB 623. SB 623 would have established the Safe and Affordable Drinking Water Fund in the State Treasury and would have provided that the moneys in the fund be continuously appropriated to the State Water Resources Control Board (State Board) for grants, loans, contracts, or services to assist those without access to safe and affordable drinking water consistent with a fund implementation plan to be adopted annually by the State Board. On August 21, 2017, the bill was amended to include a fee on fertilizer and agriculture operations, and a monthly water tax on the following:

- \$0.95 per month for meters less than or equal to 1-inch;
- \$4.00 per month for meters less than or equal to 2-inch;
- \$6.00 per month for meters less than or equal to 4-inch;
- \$10.00 per month for meters greater than 4-inch; and
- Customers without a meter would be taxed at a rate of \$0.95.

SB 623 remained in the Assembly Rules Committees throughout 2018. IRWD opposed the bill and advocated against any water tax inconsistent with the Board-adopted policy on a public good charge/statewide user fee.

While SB 623 remained in the Assembly Rules Committee, the Administration released a budget trailer bill in the spring of 2018 labeled as the "Safe and Affordable Drinking Water Act" which proposed in the form of a budget trailer bill the agricultural fees and water tax included in SB 623. While the trailer bill was not passed by the Legislature, the water tax was still discussed widely by the Administration and promoted by several prominent members of the Legislature.

In August 2018, the Administration revived and modified its trailer bill proposal. The new proposal included the fees on fertilizer and agriculture along with a voluntary "water tax". The voluntary "water tax" would have required water agencies to place on each customer's bill a recommended voluntary remittance to fund safe and affordable drinking water in the state.

On August 16, 2018, SB 844 and SB 845 were "gutted and amended" to reflect the Administration's most recent proposal. The author of both bills was Senator Monning. SB 844 was tagged as requiring a 2/3 vote because of the taxes proposed for fertilizer and agriculture while SB 845 was tagged as requiring a majority vote because Legislative Counsel concluded it was not a tax due to the voluntary nature of the remittance. On August 22, both bills were amended slightly and on August 24, the bills, which were conjoined, were referred to the Assembly Committee on Appropriations.

At the end of session, Assembly Speaker Anthony Rendon (D-Lakewood) announced that the bills would not move forward this year stating that a piecemeal approach would not work. He committed to working on the safe and affordable drinking water issues next year, and announced that Assemblymembers Eduardo Garcia (D-Coachella) and Heath Flora (R-Ripon) would lead the Assembly's effort on the matter. that SB 844 and SB 845 remain in the Assembly Committee on Appropriations at the end of session. Staff will continue to work with the Association of California Water Agencies (ACWA) and the District's other industry partners to oppose a water

tax and the voluntary remittance while promoting alternative actions to solve the water quality challenges faces a number of disadvantaged communities in the state.

AB 1000 (Friedman, D-Glendale) — Water Conveyance: Use of Facility with Unused Capacity: Assemblymember Laura Friedman (D-Burbank) introduced AB 1000 in 2017. The bill would have authorized the California Energy Commission to adopt regulations establishing performance standards for water meters installed in residential and nonresidential buildings. On July 3, 2017, AB 1000 was "gutted and amended."

As amended, the bill specifically sought to prohibit water from the Cadiz Valley Water Conservation, Recovery & Storage Project from being placed into an existing water conveyance facility unless the State Lands Commission found that there would be no adverse effect on the natural or cultural resources. At the end of the 2017 session year, AB 1000 was held on the Senate Appropriations Committee Suspense File, where it still resides. IRWD adopted a "watch" position on AB 1000.

On August 24, 2018, provisions similar to those in AB 1000 were placed into SB 120, authored by Senator Richard Roth (D-Riverside) and co-authored by Assemblymember Friedman. SB 120, as amended, was heard and passed by the Assembly Natural Resources Committee on August 28. The bill was then passed by the by the Assembly on a vote of 50 to 25. When the bill was transferred to the Senate for a vote of concurrence amendments, the bill was referred to the Senate Committee on Appropriations. The bill was held in Senate Appropriations at the end of session.

AB 1912 (Rodriguez, D-Pomona) — Joint Powers Authority: Public Employees' Retirement Liability:

Existing law permits two or more public agencies to form a joint powers authority (JPA). A JPA is a separate entity from the public agencies that form it; however, under existing law, the debts, liabilities and obligations of the JPA become the debts, liabilities and obligations of its member agencies unless the agreement governing the JPA states otherwise. In the case of pension and retirement obligations, the JPA agreement may limit those obligations and liabilities to be obligations and liabilities of the JPA alone. AB 1912, authored by Assemblymember Freddie Rodriguez (D-Pomona), would change this.

Specifically, AB 1912, as amended, would prohibit the agreement governing the JPA from limiting the pension and retirement obligations to the JPA. This means that AB 1912 would retroactively make public agencies that are members of a JPA liable for the JPA's pension and retirement liabilities.

AB 1912 was passed by the Senate on a vote of 27 to10 and by the Assembly on a vote of 44 to 6. The bill will be presented to the Governor for his signature or veto. IRWD did not adopt a position on AB 1912, but has actively monitored the bill throughout the legislative session.

AB 2050 (Caballero, D-Salinas) — Small Water System Authority Action of 2018.

In addition to the discussions taking place on a water tax to address water quality issues within disadvantaged communities, the water community has supported AB 2050 (Caballero, D-Salinas) as one way to address the challenges facing many communities in the state. The Eastern Municipal Water District (EMWD), in partnership with the California Municipal Utilities Association (CMUA), have sponsored AB 2050 to address the management and governance challenges facing water systems within disadvantaged communities.

AB 2050 would create a new category of water agency — a Small System Water Authority — with unique powers to absorb, improve and competently operate currently non-compliant public water systems with either contiguous or non-contiguous boundaries. Small System Water Authorities would consolidate failing small water systems that are voluntarily donated to the Authority to provide technical, managerial and financial capabilities to ensure the provision of safe, clean, affordable, and accessible water and local governance.

AB 2050 was passed by the Senate on a vote of 34 to 3 and by the Assembly on a vote of 58 to 21. The bill will be presented to the Governor for his signature or veto. Given the important role governance will play in California's ability to address water quality issues within disadvantaged communities, IRWD has a "support" position on AB 2050.

AB 2447 (Reyes, D- San Bernardino) — California Environmental Quality Act: Environmental Justice:

AB 2447, authored by the Assemblymember Eloise Reyes (D-San Bernardino), would expand the requirements of the California Environmental Quality Act (CEQA) for certain projects and provide for an additional process for certain projects located near or in disadvantaged communities. Specifically, the bill would require that a lead agency that is preparing an Environmental Impact Report to provide individual notice to owners and occupants of property located within a disadvantaged community when the CEQA review involves industrial or equivalent land uses.

Over the past seven months, staff has been working with ACWA and CMUA to seek amendments to the bill which would make it clear that water and wastewater projects are excluded from the bill's provisions. While the author did not accept the full set of amendments requested by ACWA and CMUA, the author did amend the bill on August 24. As amended, the bill would not apply to "A project undertaken by a public water supplier or public agency for the conveyance, production, storage, impoundment, or treatment of safe and reliable water, such as recycled water, wastewater, and stormwater, to serve a disadvantaged community."

AB 2447 was passed by the Senate on a vote of 25 to 13 and by the Assembly on a vote of 42 to 30. The bill will be presented to the Governor for his signature or veto.

AB 2501(Chu, D-Milpitas) — Drinking Water: Consolidation and Extension of Service:

AB 2501, authored by Assemblymember Kaasen Chu (D-Milpitas), seeks to amend the consolidation authorities granted to the State Board in SB 88 (2015). SB 88 authorized the State

Board to order a water system to take over and consolidate with a public water system or a state small water system that consistently fails to provide an adequate supply of safe drinking water within a disadvantaged community in order to ensure that those communities would no longer receive unsafe drinking water. In addition to the authority granted in SB 88, AB 2501 seeks to extend the State Board's consolidation authority. Among other things, if enacted, AB 2501 would allow the State Board to order a water system to take over, consolidate or provide service where the disadvantaged community is served a domestic well that consistently fails to provide an adequate supply of safe drinking water or where a school is served with unsafe or inadequate water supply.

AB 2501 was passed by the Senate on a vote of 26 to 13, and by the Assembly on a vote of 54 to 22. The bill will be presented to the Governor for his signature or veto. IRWD did not adopt a position on AB 2501, but actively monitored the bill.

AB 3206 (Friedman, D-Burbank) — Water Conservation: Water Meters: Accuracy and Performance Standards:

Assemblymember Friedman also authored AB 3206 to reduce water loss and water waste. This bill would have required the California Energy Commission to adopt regulations setting standards for the accuracy of water meters purchased on and after the effective date of the regulation setting the standards. Additionally, the bill would have required the State Board, when adopting the water loss standards under SB 555 (2016), to adopt regulations related to the sampling and testing of its meters to establish a statistically sound estimate of the accuracy of the water meters serviced by the urban water supplier.

The bill was placed on the Senate Appropriations Committee Suspense File on August 6, 2018, and was not released when the file was considered on August 16. IRWD had sought amendments to the bill which would make it more workable for the District and the water industry.

SB 998 (Dodd, D-Napa) — Discontinuation of Residential Water Service:

SB 998, authored by Senate Bill Dodd (D-Napa), would establish new statutory provisions governing when a public water system may discontinue water service at a residential property. Among its many provisions, the bill would prohibit a public water system from discontinuing residential water service for nonpayment until a customer has been delinquent for at least 60 days and has been provided adequate notice about their options to avoid discontinuation of their water service. The bill also prohibits, if certain situations exist, the discontinuation of water service. The bills would prohibit the discontinuation of residential water service where all of the following conditions are met:

• The customer, or a tenant of the customer, submits to the water provider certification from a licensed medical professional that that discontinuation of residential service will be life-threatening to, or pose a serious threat to the health and safety of, a resident of the premises where the service is being provided;

- The customer demonstrates that he or she is financially unable to pay their bill within the normal payment period; if any member of the customer's household is a recipient of CalWORKS, CalFresh, general assistance, Medi-Cal, Supplemental Security Income/State Supplementary Payment Program, or California Special Supplemental Nutrition Program for Women, Infants and Children; or he or she declares that the household's annual income is less than 200 percent of the federal poverty level; and
- The customer is willing to enter into an amortization agreement, alternative payment schedule or plan for deferred or reduce payment with respect to the delinquent charges.

Additionally, the bill limits a water provider's ability to discontinue service if the customer is delinquent on a payment required under an amortization agreement, alternative payment schedule or plan for deferred or reduced payment plan. The bill would require that service could not be discontinued until the customer was 60 days delinquent on those charges.

SB 998 also limits reconnection fees and interest charges on past due bills. The bill limits reconnection fees to \$50.00 or less for a reconnection during normal operating hours and \$150.00 or less during non-normal operating hours for households with income below 200 percent of the federal poverty line. It would also require that interest charges be waived for a residential customer who demonstrates to a water provider that their household income is below 200 percent of the federal poverty line.

IRWD took an "oppose" position on SB 998 because the author rejected the amendments requested by the water community which would have made the bill consistent with Proposition 218's cost-of-service requirements.

SB 998 was passed by the Assembly on a vote of 44 to 26 and by the Senate on a vote of 25 to 13. The bill will be presented to the Governor for his signature or veto.

SB 1215 (Hertzberg, D-Van Nuys) — Provision of Sewer Service: Disadvantaged Communities:

SB 1215, authored by Senator Hertzberg (D-Van Nuys), would expand the Regional Water Quality Control Boards' (regional boards) authority. Specifically, SB 1215 would authorize the regional boards to order a sewer service provider to extend service to a disadvantaged community or where the residents of a disadvantaged community are served by an onsite sewage treatment system (i.e. septic systems) that does not provide adequate sewage service. If a regional board orders the provision of sewer service, the bill would require the State Board to make funds available, upon appropriation by the Legislature, to the receiving sewer system for the costs of providing the sewer service including compensation of loss of capacity, and paying capacity connection fees.

SB 1215 was passed by the Assembly on a vote of 54 to 23, and by the Senate on a vote of 29 to 10. The bill will be presented to the Governor for his signature or veto. IRWD did not take a position on SB 1215, but actively monitored it.

2018 State Regulatory Update:

California Water Plan- Update 2018:

The Department of Water Resources (DWR) is currently working on the 2018 update to the California Water Plan. The California Water Plan is the State's strategic plan for managing and developing water resources. The 2018 Update seeks to "ever-green" the plan by identifying specific outcomes and metrics to track performance, prioritize near-term State actions and investments, recommend financing methods having more stable revenues, and inform water deliberations and decisions. More specifically, the current version of the 2018 Update, which was released in January 2018, focuses on the following areas and visions:

- Public Health and Safety Vision All Californians are protected from health and safety threats and emergencies;
- Health Economic Vision California has a healthy economy and all Californians have opportunities for economic prosperity;
- Ecosystem Vitality Vision Ecosystems in the state are thriving; and
- Opportunities for Enriching Experiences Vision All Californians have opportunities for enriching experiences.

In March, IRWD submitted a formal comment letter on the Public Review Draft. While the next version of the update was due for release in the spring, the next version of the update is yet to be released. Despite this, DWR has scheduled the next Plenary on the 2018 Update. The goals of the Plenary are to provide an overview of the Public Review Draft, solicit feedback on the draft and discuss implementation strategies and tools related to the 2018 Update. Given the importance of the 2018 Update and the many controversial proposals included in the Public Review Draft, staff is planning on attending the Plenary to continue advocating for changes to the draft.

State Water Resources Control Board Proposed Recycled Water Policy Amendments:

In May, the State Board released proposed amendments to the "Policy for Water Quality Control for Recycled Water" (e.g. the Recycled Water Policy). The proposed amendments greatly change the policy from being focused on the use of recycled water for irrigation to a more overarching regulatory/policy document that will govern the terms of permits issued to recycled water producers and purveyors.

On June 19, 2018, the State Board held a public hearing to accept oral comments on the proposed amendments to the Recycled Water Policy. Staff participated in the hearing providing comments on the reporting, permitting and overarching policy goals of the proposed amendment. On June 26, 2018, IRWD submitted formal comments on the proposed amendments.

Since the hearing and the close of the official public comment period, staff has continued to work with WateReuse California and others to seek changes to the proposed amendments. Staff will provide an update on any significant developments related to those efforts.

"Making Water Conservation a California Way of Life" Implementation:

Last month, DWR along with the State Board, released a primer on the long-term water use efficiency legislation passed earlier this year. Along with the release, the agencies announced that they will be hosting listening session and accepting public comments on "Making Water Conservation a California Way of Life: Primer of 2018 Legislation on Water Conservation and Drought Planning" through September 14, 2018. Staff has reviewed the primer and will be participating in the listening session to encourage DWR and the State Board to make the primer more consistent with the "Making Water Conservation a California Way of Life" legislation engaged this year.

In order to have a proposal considered for next year, CMUA requires the proposal to be submitted by October 5, 2018.

Request for Qualifications for Federal and State Legislative Advocates:

Given the restructuring and/or retirement of the District's current federal and state advocates, staff plans to issue a Request for Qualifications (RFQ) to solicit qualifications from full-service lobbying firms to represent the District on federal legislative and regulatory issues in Washington, D.C, and on state legislative issues in Sacramento. The RFQ for federal advocacy services is planned for release this month while the release of the RFQ for state advocacy services will take place in early fall.

MICHELSON WATER RECYCLING PLANT SECURITY FENCING <u>FINAL ACCEPTANCE</u>

SUMMARY:

The Michelson Water Recycling Plant (MWRP) Security Fencing project is complete. The contractor, La Habra Fence, completed the required work and all punch list items. The project has received final inspection and acceptance of construction is recommended.

BACKGROUND:

This project constructed a security fencing system along the entrance drive to the Operations Center between Gate 1, which is the current primary vehicle access point for staff and visitors, and the flagpole area. The system separates the parking areas for visitors and staff, as well as directs visitors to use the main entrance doors to the Operations Center. The fencing improvements include: 1) approximately 760 feet of black vinyl-coated chain link fencing, 2) one black vinyl-coated chain link double swing gate, 3) 130 feet of black ornamental steel fencing, 4) two black ornamental steel pedestrian gates, and 5) one black ornamental steel double-swing vehicle gate.

Staff completed the design in January 2018 and La Habra Fence was awarded the construction contract on March 6, 2018. La Habra Fence mobilized in May 2018 and completed construction of all improvements on August 30, 2018.

SUMMARY:

The UCI Cooling Tower Recycled Water Conversion Pipeline Project is complete. The contractor, Sully-Miller Contracting Company, completed the required work and all punch list items. The project has received final inspection and acceptance of construction is recommended.

BACKGROUND:

The UCI Cooling Tower Conversion Recycled Water Pipeline Phase II project constructed 3,285 feet of 12- and 16-inch pipe to convert the water supply of the UCI Cooling Tower system from domestic to recycled water, as well as provide recycled water to the planned growth in the University Research Park area. The conversion of the cooling tower is estimated to save up to 50 million gallons of domestic water annually. A Memorandum of Understanding (MOU) outlining the terms of UCI's commitment to use recycled water was executed on January 23, 2017.

CivilSource NV5 completed the design in July 2017 and Sully-Miller was awarded the construction contract on September 11, 2017. Sully-Miller mobilized in October 2017 and completed construction of all improvements on June 29, 2018. A staff report is shown in Exhibit "A" summarizing the construction contract change orders.

Staff Report For UCI Cooling Tower Recycled Water Conversion Pipeline Phase II September 10, 2018

This staff report summarizes the contract change orders to Sully-Miller Contracting Company for work added to and deleted from the original bid items of work.

1. Contract Change Order No. 1

Contract Change Order No. 1 was for \$66,675.97 and 14 additional calendar days were required. The additional work items included:

- UCI mismarked its 12-inch asbestos cement (ACP) domestic water line by nine feet at the intersection of Academy Way and Peltason Drive and Sully-Miller struck the existing pipeline during construction. Additional work was required to temporarily repair the pipe until the repair couplings could be procured, stabilize the road, and re-route the new pipe alignment.
- Potholing was required to locate the 12-inch domestic water main alignment in Peltason as UCI was not able to accurately mark the location of its ACP water main.
- Hard and rocky soil was encountered along the pipe alignment between Peltason Drive and Mesa Road which slowed Sully-Miller's pipe installation rate.
- Hand digging was required underneath an unmarked gas line in California Avenue.
- Installing 22-degree fittings on the 16-inch PVC pipe on Academy Way due to the new alignment.

2. Contract Change Order No. 2

Contract Change Order No. 2 was for \$237,088.70, and 38 additional calendar days were required. The additional work items included:

- Permanent repair of UCI's 12-inch ACP domestic water line.
- Additional potholing to determine locations of the existing utilities at the intersection of Peltason Drive and Academy Way and find a feasible pipe alignment as the existing three electrical duct banks, sewer pipe, gas main, and water pipe were all aligned side-by-side with little space between, and open trench pipe construction underneath was not feasible.
- Bore and jack installation of the pipe at Peltason Drive and Academy Way since open trench installation was not possible due to conflicts with existing utilities. Since staff and Sully-Miller could not agree to the cost to excavate and backfill the bore and jack pits, the work was performed on a time and material basis and included on a subsequent contract change order.
- Hard and rocky soil was encountered along the pipe alignment in Peltason Drive delaying the installation by 11 work days. Soil borings were drilled along the

pipe alignment during the design phase to determine soil conditions; unfortunately this rocky soil area was located between two of the soil borings.

- Two 45-degree bends to reroute the pipe alignment to avoid existing utilities in Peltason Drive.
- Extending the two 8-inch service laterals to the cooling tower's on-site plumbing system as requested by UCI. This work was coordinated with the contractor working on the on-site cooling tower conversion.
- 3. Contract Change Order No. 3

Contract Change Order No. 3 was for \$13,446 and two additional calendar days were required. The additional work items included:

- At one of the two 8-inch service lateral extensions (mentioned previously) to the Cooling Tower's on site plumbing, additional work was needed to hand dig the trench due to the service lateral crossing beneath two large diameter at-grade pipelines at the cooling tower facility.
- 4. Contract Change Order No. 4

Contract Change Order No. 4 was for \$74,011.72 and six additional calendar days were required. The additional work items included:

- The cost to excavate bore and receiving pits, haul off excavated dirt, begin construction of the bottom drain and Cathodic Protection Test Station (CPTS) for bore and jack casing, remove and replace sidewalk for bottom drain and CPTS installation.
- 5. Contract Change Order No. 5

Contract Change Order No. 5 was for \$22,071.66 and two additional calendar days were required. The additional work items included:

- The cost to backfill the jack and bore pits and open road after bore and jack pipe installation.
- 6. Contract Change Order No. 6

Contract Change Order No. 6 was for \$55,842.46, and 65 additional calendar days were required. The additional work items included:

• The cost to complete installation of the bottom drain and CPTS behind the curb and pave the bore and jack pits.

- Grind and cap pavement of an additional 16,712 square feet at the bid unit price of \$2.50 per square foot due to several pipe alignment changes made in Peltason Drive.
- Slurry seal an additional 38,929 square feet at the bid unit price of \$0.45 per square foot due to the pipe alignment changes and City of Irvine inspector requirements.
- Deduction of 65 feet of 12-inch C900 PVC pipe. 2,700 feet of 12-inch PVC pipe was included in the bid schedule, and 2,635 feet of 12-inch PVC pipe was required to construct the pipe.
- Deletion of a sewer cleanout on the existing sewer in Peltason Drive close to a bottom drain on the new recycled water pipeline to facilitate draining and disposal of water. An existing sewer manhole will be used instead.
- An additional 63 calendar days be added as a non-compensatory time extension to complete the project. The schedule to place AC grind and cap paving, slurry seal, and striping was coordinated with UCI for the necessary street closures. The streets could only be closed on Saturdays, and Peltason Drive is near the athletic fields and the Bren Events Center where athletic events occurred on Saturdays in May. Scheduling the work for Saturdays without campus events delayed the work.

RENEWAL OF GROUP MEDICAL AND DENTAL INSURANCE PLANS FOR PLAN YEAR 2019

SUMMARY:

CalPERS Health Benefits Services has notified participating agencies of premium rates for the 2019 plan year beginning January 1, 2019. ACWA/JPIA has negotiated rates for dental insurance with Delta Dental for the plan year beginning January 1, 2019. Staff recommends that the Board:

- Continue the District's medical insurance plans with CalPERS for the 2019 plan year with changes in District and employee contribution rates as displayed in Exhibit "A"; and
- Renew IRWD's existing contract with ACWA/JPIA for Delta Dental DPO Plan A with the child and adult orthodontic plan add-on with no changes in premium rates for the 2019 plan year.

BACKGROUND:

CalPERS Medical Insurance Renewal Information:

The District currently utilizes the CalPERS medical insurance program to provide medical insurance plans for District employees. Each year, in advance of the annual insurance benefit open enrollment period, the District receives the premium rates for each medical insurance plan for the upcoming calendar year. The CalPERS medical insurance plan premium rate changes for the 2019 plan year include an average 1.16% overall increase, marking the lowest medical insurance premium rate increase CalPERS has negotiated in over two decades. CalPERS has notified the District of premium rate changes for each of the specific plans from which IRWD employees may choose. The 2019 plan year premium rates and District contribution rates for each CalPERS health insurance plan are shown in Exhibit "A".

Dental Coverage:

IRWD's current employee dental insurance plan is provided by Delta Dental Plan of California through ACWA/JPIA. IRWD currently contracts through ACWA/JPIA for the DPO Plan A with the child and adult orthodontic plan as an add-on. The ACWA/JPIA rate negotiations with Delta Dental for calendar year 2019 resulted in no changes to the premiums for the DPO Plan A with the child and adult orthodontic plan add-on. Premium rates will remain unchanged from the 2018 rates.

The 2019 plan year premium rates for the Delta DPO Plan A with the child and adult orthodontic plan add-on are \$35.36 for employee only, \$69.99 for employee plus+1, and \$128.10 for family. ACWA/JPIA's administration fee is \$2.24 per enrollee per month which is included in the premium rates.

Open Enrollment Process for 2019:

The CalPERS 2019 health insurance open enrollment period will begin in mid-September and close in early November of 2018. In September, Human Resources staff will conduct employee open enrollment informational meetings and will conduct the annual Employee Health and Wellness Fair. Insurance plan representatives have been invited to attend the Wellness Fair to provide information to employees about the details of the plans offered for enrollment.

Employee and Employer Contribution Rates:

The District has a long-standing practice of calculating the employer and employee contribution rates for health insurance premiums based on rates of the Preferred Provider Organization (PPO) plan offered, which had the highest enrollment in the prior plan year. The rates for that plan are then used to calculate the maximum District contribution rates for all plans offered.

In the 2018 plan year, the PPO plan offered with the highest enrollment was the PERS Choice-PPO – Other Southern California Region (OSC) plan. The premium for this plan will increase 3.17% for the 2019 renewal, therefore, the District's maximum contribution rates will increase to align with the higher 2019 PERS Choice-PPO – Other Southern California Region(OSC) plan premiums. The proposed 2019 District and employee health insurance premium contribution rates for each health plan offered under the CalPERS Health Insurance Program are outlined in Exhibit "A".

CalPERS Administrative Fees and Reserves:

On June 26, 2018, the CalPERS administrative fee was set at 0.23% for the July 1, 2018 to June 30, 2019 fiscal year. This represents a decrease from the prior year of 0.33%. The administrative fee is calculated based on total active and retiree gross health premiums and billed to contracting agencies monthly. CalPERS can also charge up to 4% for a contingency reserve fund; however, a contingency fee has not been assessed since 1985. For the 2019 plan year, staff has not been notified of any contingency reserve fees.

FISCAL IMPACT:

Continuation of the CalPERS medical insurance plans will result in expenses for FY 2018-19 of \$4,850,444. Actual District medical insurance expenses for FY 2017-18 were \$4,780,345. The FY 2018-19 expenses represent a 1.4% (\$70,099) increase over the FY 2017-18 expenses. Annual medical insurance premiums for FY 2018-19 will be approximately 89% (\$4,850,444) of the budgeted \$5,423,000.

Renewal of the ACWA/JPIA for Delta Dental DPO Plan A with the child and adult orthodontic plan add-on will result in no change in premium rates. Annual dental insurance premiums for FY 2018-19 will be approximately 100% (\$442,000) of the budgeted \$442,000.

REVISED DEFERRED COMPENSATION INVESTMENT POLICY STATEMENT

SUMMARY:

In April 2018, the Finance and Personnel Committee approved the addition of Vanguard Target Date Funds as an investment option for the District's deferred compensation IRS Section 457 and 401(a) Plans (Plans), as well as the replacement of the Conservative Profile Fund with the age-appropriate Target Date Fund as the Plans' default investment option. The changes have been incorporated into the Proposed Deferred Compensation Plan Investment Policy Statement and are recommended for Board approval.

BACKGROUND:

In March 2018, the District's deferred compensation plan consultant, Hyas Group, was retained to review the deferred compensation Plan investment options. Based on the consultant's review, the Committee authorized the addition of Vanguard Target Date Funds as an investment option for the Plans. The Committee also approved the replacement of the Conservative Profile Fund with the age-appropriate Target Date Fund as the new default investment option for the Plans.

Staff has revised the Deferred Compensation Investment Policy Statement (Policy) to include the above changes, which is recommended for Board approval. The Proposed Policy is attached as Exhibit "A".

The Irvine Ranch Water District's (The "District") IRS Section 457 Deferred Compensation Plan (the "457 Plan") and the Money Purchase 401(a) Plan; (collectively the "Plans") were established to create tax-deferred retirement savings vehicles for Plan participants and their beneficiaries. The purpose of this Investment Policy Statement (the "Policy Statement") is to guide the Plan Administrators in effectively supervising, monitoring and managing the investment options available under the Plans. This Policy Statement is designed to allow for sufficient flexibility in the management oversight process, while also setting forth reasonable parameters to promote the exercise of prudence and care with respect to the investment options available under the Plans. This Policy Statement provides a framework for the ongoing evaluation of the investment options available under the Plans, and guidelines for terminating and replacing investment option(s).

PLAN FIDUCIARIES AND DELEGATION OF AUTHORITY:

Several fiduciaries have varying responsibilities with respect to the Plans. Plan fiduciaries include:

Plan Sponsor:

The District is the Plan Sponsor. The Plan Sponsor's responsibilities, exercised through the Board of Directors (the "Board"), include:

- Appointing the members of the Finance and Personnel Committee (through the District's Board President)
- Appointing the Plan Trustee(s) and Plan Administrator(s)
- Approving the <u>Investment</u> Policy Statement
- <u>Approving Employee Benefit Plan Changes</u>

Finance and Personnel Committee:

The Finance and Personnel Committee will act as the Deferred Compensation Committee (the "Committee"). The Committee's responsibilities include:

- Selecting the record-keeper and any outside plan advisors
- Quarterly review of the investment options
- Approving the addition or replacement of investment options

Trustee(s) and Plan Administrator(s):

The Treasurer and the Assistant Treasurer(s) will act as the Trustee and Plan Administrators (the "Plan Administrators"). The Plan Administrator's responsibilities include:

- Carrying out instructions from the Board and/or the Committee
- Accounting for <u>the Pplans</u>' assets
- Quarterly review of investment performance and recommending changes to the Committee
- Managing the operation and administration of the Plans
- Monitoring the Plans for compliance with all applicable laws, rules and regulations

BACKGROUND:

The Plans are intended to provide eligible employees with a means to save money on a taxdeferred basis in order to assist the employee in reaching his/her retirement goals. The Plans allow each eligible employee to direct how contributions made to his or her accounts are invested among a diverse menu of investment options approved by the Committee. Specific information pertaining to participant eligibility can be found in the District's <u>Deferred</u> <u>Compensation</u> Personnel Policy #39.

The Plan Administrators will make recommendations to the Committee related to which investment options will be available in the Plans and will monitor the investment options' compliance with this Policy Statement.

The District will provide periodic investment educational opportunities for participants; however, the District, the Committee or the Plan Administrators will not provide specific investment advice to any participant or assist any participant in deciding how to allocate contributions to the participants' accounts.

CORE INVESTMENT OPTION SELECTION:

The Committee recognizes that there is investment risk inherent in all investment options and further recognizes that individual participants each have their own level of risk tolerance. To this end, the Committee will select a broad array of investment options providing different levels of risk and historical returns based upon the following criteria:

- 1. Selected investment options will represent major asset classes. For purposes of this Policy Statement, the following major asset classes will be used, at a minimum, as defined by Morningstar® (an independent mutual fund evaluation company):
 - a. International-Equity Fund;
 - b. U.S. Small-Cap Equity Fund;
 - c. U.S. Mid-Cap Equity Fund;
 - d. U.S. Large-Cap Equity Fund;
 - e. Index Funds

f. Bond Fund;

g.__Fixed Income/Stable Value;

h. Asset Allocation_Profile Funds (diversified portfolio of funds with varying degree of risk).

i. <u>Asset Allocation Target Date Funds (diversified portfolio of funds with varying target retirement dates).</u>

- 2. Pertaining to funds in the domestic equity asset classes identified above in 1(b), 1(c) and 1(d), the Committee will attempt to choose investment options with contrasting stock selection styles that purchase "value" stocks (stocks that are purchased because the fund manager believes the stock is undervalued) and "growth" stocks (stocks of companies that have shown accelerated earnings), and/or funds that invest in both "value" and "growth" stocks, commonly referred to as "blend" funds.
- 3. The Committee will also evaluate the fund management, pricing and other mutually agreeable criteria in cooperation with the Plan's' recordkeeperrecord-keeper.
- 4. The expense ratios of the investment options must be competitive with other investment options with similar objectives as measured by the applicable Morningstar® Category average.
- 5. The Plan Administrators may use a consultant for any approved purpose related to the Plans, including providing analysis and recommendations for investment options to be included in the Plans.

5.6.Participants that fail to make an affirmative investment election will be "defaulted" into a Target Date Fund whose expected retirement date (as listed in the fund's name, e.g. "Target Date 2050") is closest to the date the participant will reach 62 years of age. If the participant's age is greater than 62 years and there is no corresponding fund available, the participant they will be defaulted into the Target Date Retirement Income Fund.

INVESTMENT OPTION PERFORMANCE STANDARDS:

The Committee will review each of the selected core investment options on a quarterly basis to evaluate the investment option's performance. Advised Assets Group (AAG), a wholly-owned subsidiary of Great-West Life & Annuity Insurance Company, will perform the annual fund evaluation. The AAG methodology and fund performance review <u>criteria iscriterion is</u> attached to this policy as Exhibit "A".

Based on the fund review provided by AAG, the Committee will take the following steps:

- 1. If any investment option is rated "Below" in the Overall Rating Criteria, the Committee will place the option on "watch status".
- 2. If any investment option is rated as "Fail" in the Long-term Rolling Analysis due to being classified as "Below" its prescribed Overall Rating benchmarks for the four most recent consecutive quarters or seven out of the trailing twelve quarters, then the investment option has "Failed" the Long-Term Rating and the investment will be a candidate for replacement.

I

- The Committee may select a new investment option in the same asset class and designate an existing or new investment option to receive the assets from the investment option that failed its benchmarks.
- If an investment option is terminated, Plan Administrators will notify participants of the investment option to be terminated, and which investment option(s) will be used to receive assets from the terminated fund.

The Committee may also decide to place place a fund on "watch status" if it is determined that an investment option has failed to meet certain Policy criteria. In the event a "watch status" is initiated, the investment option will be subject to an additional level of evaluation and may become a candidate for replacement. An investment option may remain on watch status until the Committee decides to take further action Hincluding replacement or removal from "watch status".

While the primary analysis of the investment option will be quantitative, the Committee reserves the right to make decisions regarding the investment options based upon other criteria that it believes will be in the best interest of the Plans and the participants. Other criteria that may be considered include: management personnel departures; organizational changes; alterations in investment style, philosophy, or strategy; and adherence to stated guidelines.

SELF-DIRECTED BROKERAGE ACCOUNT OPTION (SDBA):

The SDBA is offered in the Plans. This option is available to all participants and allows participants to select additional mutual funds, stocks, covered stock options, and bonds. Neither the District nor AAG monitors the performance of the investments made by participants within the SDBA and does not make any representations or guarantees concerning the appropriateness or soundness of any investment available through the SDBA.

Prior to using the SDBA, participants must accept the terms of the account, including certification that they are a knowledgeable investor, acknowledgement of the risks and fees associated with the use of the brokerage option, and agree to release, hold harmless and indemnify the District, the Plans, and the Plan Trustees and Administrators from any and all liability for any negative consequences.

OTHER:

This Policy Statement is not intended to be a legal document or construed as legal advice. It is intended to be a guide and describes the prudent investment process that the District deems most appropriate for the Plans. The Plan Administrators will review this policy at least annually and recommend changes as needed to the Committee and the Board.

ORANGE COUNTY GREAT PARK REACH A SEWER IMPROVEMENTS BUDGET INCREASE AND CONSTRUCTION AWARD

SUMMARY:

The project includes upsizing the existing Great Park Reach A sewer, bore and jack sewer construction under Interstate 5 freeway, and miscellaneous manhole improvements. Staff recommends that the Board approve a budget increase in the amount of \$1,055,100, from \$652,000 to \$1,707,100, and authorize the General Manager to execute a construction contract with T.E. Roberts, Inc. in the amount of \$1,251,110 for the Orange County Great Park Reach A Sewer Improvements, Project 10068.

BACKGROUND:

FivePoint constructed the Reach A sewer in 2014 to serve the planned development at the Great Park. After constructing the sewer, FivePoint increased the number of proposed dwelling units at the Great Park, which prompted the need to upsize the Reach A sewer. FivePoint has since upsized various portions of the sewer within its development, and IRWD is upsizing the offsite portion of the sewer through Irvine Company property and under the Interstate 5 freeway as shown on the location map attached as Exhibit "A". The project includes upsizing approximately 1,500 feet of 15-inch diameter sewer pipeline to 18-inch diameter sewer pipeline and miscellaneous manhole improvements. Approximately 450 feet of the upsized sewer will be constructed under Interstate 5 freeway via bore and jack.

Construction Award:

Staff advertised the project for bids on July 26, 2018 to a select list of 12 contractors including CCL Contracting, E.J. Meyer Company, GCI Construction, Kennedy Pipeline Company, L&S Construction, Leatherwood Construction, Mladen Buntich Construction, Paulus Engineering, Steve P. Rados, Sukut Construction, T.E. Roberts, and W.A. Rasic Construction. The bid opening was held on August 30 with bids received from T.E. Roberts, L&S Construction, E.J. Meyer Company, Paulus Engineering, and Mladen Buntich Construction. T.E Roberts, Inc. is the apparent low bidder with a bid amount of \$1,251,110. The remaining bids ranged between \$1,781,400 and \$2,514,450. The engineer's estimate, prepared by MBF Consulting, was \$1,285,000. The bid summary is attached as Exhibit "B".

Staff reviewed T.E. Roberts, Inc.'s bid and has determined that it is responsive. Staff recommends that the Board authorize the General Manager to award a construction contract to T.E. Roberts, Inc. in the amount of \$1,251,110.

Project 10068 is included in the FY 2018-19 Capital Budget and will be funded through development funds. A budget increase of \$1,055,100 is required to fund the construction services as shown in the table below.



PROPOSED IRWD POLICY PRINCIPLES REGARDING UPDATES TO METROPOLITAN WATER DISTRICT'S LOCAL RESOURCES PROGRAM

SUMMARY:

Metropolitan Water District of Southern California (Metropolitan) is developing updates to its policies governing the implementation of its Local Resources Program (LRP). This program provides incentives to water agencies for the development of water recycling, groundwater recovery, and seawater desalination projects. To help guide IRWD's advocacy efforts related to ongoing discussions on Metropolitan's LRP policies, staff has prepared the attached policy position paper regarding updates to Metropolitan's Local Resources Program. Staff recommends that the Board adopt the proposed principles.

BACKGROUND:

In 2004, IRWD began producing policy papers on topics of particular interest to the District. Because of IRWD's standing in the water industry, the opinion of the District is regularly solicited on issues of vital interest to the industry and the community. In order to keep these position papers current and usable for explaining the District's position, staff occasionally recommends that the Board review the papers and, when appropriate, adopt new policies or incorporate revisions.

Metropolitan provides financial incentives through the LRP for the development of water recycling, groundwater recovery, and seawater desalination projects that offset a demand or prevent adding a new demand on Metropolitan for imported water supplies. The projects that Metropolitan funds provide a direct replacement of potable water or increase regional groundwater production. In 2014, Metropolitan issued the guidelines provided as Exhibit "A" for agencies to use when applying for LRP incentives. These guidelines provide details on the program, general requirements and the application process.

Existing LRP Incentive Options:

Currently, Metropolitan offers the following three LRP incentive payment structures:

Option 1: Sliding scale incentives up to \$340 per acre-foot over 25 years; *Option 2:* Sliding scale incentives up to \$475 per acre-foot over 15 years; or *Option 3:* Fixed incentives up to \$305 per acre-foot over 25 years.

Sliding scale payments are based on actual project unit costs that exceed Metropolitan's prevailing Full Service Tier-1 Treated Water Rate. Fixed incentives are negotiated such that Metropolitan's maximum obligation would not exceed 90% of Metropolitan's commitment to provide funding under Option 1. LRP incentives are contingent upon the approval of the Metropolitan Board of Directors.

LRP Policy Updates:

Metropolitan is developing potential updates to its Local Resources Program to address both near-term and long-term policy issues that are interrelated to its Integrated Resources Plan. To help guide IRWD's advocacy efforts related to ongoing discussions on Metropolitan's LRP policies, staff has prepared a policy position paper regarding updates to the Metropolitan Local Resources Program that is attached as Exhibit "B". Staff recommends that the Board adopt the proposed policy principles.

The proposed policy position paper references Metropolitan's policy principles that were adopted in July 2017 and that guide Metropolitan's role in regional implementation of Integrated Water Resources Plan targets for local resources. The adopted Metropolitan document is provided as Exhibit "C". One of the principles identified in the document states that Metropolitan should have multiple approaches for developing local resources in cooperation with other agencies. The policy position paper provided as Exhibit "B" includes recommendations for Metropolitan to consider when developing new approaches to encouraging the development of local water resources projects.

2014 Local Resources Program Application Guidelines

INFORMATION FOR RESPONDENTS

The Metropolitan Water District of Southern California (Metropolitan) invites applications for development of water recycling, groundwater recovery, or seawater desalination projects under the Local Resources Program (LRP). This package includes information regarding funding, eligibility and the application review process. Additional copies of this application package may be downloaded from Metropolitan's website at: <u>www.mwdh2o.com</u>. We look forward to working with all applicants to bolster our region's water supply reliability.

Objective

The LRP provides funding for the development of water recycling, groundwater recovery, and seawater desalination supplies that replace an existing demand or prevent a new demand on Metropolitan's imported water deliveries either through direct replacement of potable water or increased regional groundwater production.

Application Submittals

Project applications will be accepted on an open and continuous basis until the target yield of 63,000 acre-feet per year is fully subscribed. For further coordination or questions, contact Mr. Ray Mokhtari at (213) 217-6142 or via email at rmokhtari@mwdh20.com.

Who Can Apply

The LRP is open to public and private water agencies within Metropolitan's service area. Applications must be made through the applicant's respective Metropolitan member agency. Applicants are strongly encouraged to initiate early coordination with Metropolitan regarding proposed projects. Submittal of a LRP application does not signify or guarantee funding approval by Metropolitan.

Program Funding

There are three LRP incentive payment structure options to choose from: sliding scale incentives up to \$340/AF over 25 years, sliding scale incentives up to \$475/AF over 15 years, or fixed incentive up to \$305/AF over 25 years. One option must be chosen at the time of application. Combinations of options will not be permitted. Incentive commitments are contingent upon

approval by Metropolitan's Board of Directors. See attachment C for more information and incentive rate calculation process.

Annual Cost Reconciliation for Sliding Scale Incentive Options

As outlined in Exhibit C, sliding scale incentives are calculated annually based on the actual project unit cost exceeding Metropolitan prevailing water rate as established by Metropolitan's Administrative Code § 4401. Prior to each fiscal year of operation, Metropolitan will set an estimated LRP incentive rate for deliveries during the year. At the end of each fiscal year, Metropolitan will conduct a cost reconciliation to determine the actual LRP incentive rate based on the actual project unit cost exceeding Metropolitan's prevailing water rate in that year. After reconciliation, over- or under-payment adjustments are made between Metropolitan and the agency. The calculated incentive rate may diminish in future years as Metropolitan's water rates increase or the project unit costs decrease as annual yield increases.

Eligible Projects

New water recycling, groundwater recovery, and seawater desalination projects are eligible for funding provided they include construction of new substantive treatment or distribution facilities. Existing projects or those that have commenced construction prior to application submittal are ineligible. Strong consideration will be given to projects that are well positioned for construction and timely production of stated project capacities in the near future. Projects with long ramp-up schedules may be addressed in phases. Agency must apply for each phase separately when each phase is poised for timely construction and operation. See Attachment C for more information.

Process Overview

Project applications will be accepted on an open and continuous basis until the target yield of 63,000 acre-feet per year is fully subscribed. Applications will be reviewed for compliance with general program requirements outlined in Attachment C. Metropolitan, at its sole discretion, may reject any and all applications and revise the terms of the LRP at any time. If a project qualifies and all environmental documents and permits are submitted, Metropolitan will draft an incentive agreement that must be approved by the respective member agency and retail agency. If Metropolitan's Board of Directors approves the project for LRP funding, the incentive agreement must then be executed by Metropolitan, member agency, and retail agency.

Performance Provisions

Performance provisions will be included in all agreements to encourage timely and responsive project development and production. These provisions reduce or withdraw Metropolitan's financial commitment to projects that do not meet development and production milestones outlined in the following table.

Application Options

A written application outlined in the following pages must be submitted to Metropolitan to start the process. Metropolitan will accept applications/reports developed by the project sponsor for other purposes (e.g., applications for state funding programs, US Bureau of Reclamation feasibility report submittals, etc.) as long as they provide needed information. All applications must include an executive summary that identifies the location of the needed information. Failure to provide an executive summary may extend the review process. After an initial review, Metropolitan will meet with each applicant to ensure an accurate understanding of project features and LRP terms.

LOCAL RESOURCES PROGRAM APPLICATION GUIDELINES

At a minimum, applicants must include the following information for Metropolitan to evaluate project eligibility for LRP funding:

- Location
- Source of water supply and yield
- Participating agencies and contractual commitments
- Complete Attachment A

Additional information for groundwater projects:

- Basin hydrology and setting
- Existing groundwater production and projected increase as a result of project
- Imported water replenishment requirements
- Previously abandoned production and/or replenishment
- Basin adjudication or operating rules
- Ability to sustain project production during 3-year shortage conditions
- Compliance with sound basin management

2) Project Facilities

- Treatment process and quality objectives
- Storage features
- List and map distinguishing existing and proposed facilities, land acquisition, etc.
- Interties to existing LRP agreements
- Interties and points of connection to other non-project facilities
- Methodology to measure project yield (e.g. metering, basin adjudication or watermaster rules if applicable)

3) Project Costs

- Capital

ATTACHMENT C LOCAL RESOURCES PROGRAM GENERAL PROGRAM INFORMATION

General Requirements

The Local Resources Program (LRP) provides incentives for development of new water recycling, groundwater recovery, and seawater desalination projects in Metropolitan's service area. Unless otherwise approved by Metropolitan, proposed projects must comply with the following general requirements:

- 1. Project must replace an existing demand or prevent a new demand on Metropolitan's imported water deliveries either through direct replacement of potable water or increased regional groundwater production.
- 2. Project must not exist or be under construction prior to application submittal.
- 3. Project must include construction of new substantive treatment or distribution facilities.
- 4. Proposals must be supported by a Metropolitan member agency.
- 5. Project must be owned and operated by the agency. Metropolitan has no ownership or operational obligations for a project.
- 6. Project must comply with the Metropolitan Water District Act and other applicable laws and regulations.
- 7. Project must comply with CEQA and/or NEPA provisions prior to Metropolitan board approval.
- 8. Project must have obtained all required Regional and State permits prior to receiving Metropolitan board approval.
- 9. Additional requirements specific to each project will be developed to address system integration issues related to use of Metropolitan's facilities, if needed.
- 10. Metropolitan's Board must approve each project prior to incentive agreement execution.

Incentive Payment Structures

Agencies can choose from one of the following three alternative incentive payment structures for each of their eligible projects to participate in the LRP:

Alternative 1 – Sliding Scale Incentives Over 25 Years (Current Payment Structure) Alternative 2 – Sliding Scale Incentives Over 15 Years (New Structure) Alternative 3 – Fixed Incentives Over 25 Years (Previously Approved Structure)

Alternative 1 - Sliding Scale Incentives Over 25 Years

Metropolitan would provide member or retail agencies a sliding scale incentive up to \$340/AF over 25 years, calculated annually based on actual project unit costs exceeding Metropolitan's prevailing water rate, for project water used within Metropolitan service area. Eligible project costs include an agency's out of pocket costs normally associated with developing local resource projects including design, capital, operations, maintenance, and replacement costs. Incentive payments are subject to an annual cost reconciliation process with adjustments for under- or over-payment to be included in subsequent water service invoices from Metropolitan.

Alternative 2 - Sliding Scale Incentives Over 15 Years

This alternative is similar to Alternative 1, but the incentive amount is up to \$475/AF over 15 years. In addition to the current LRP performance provisions, projects must continue production for 25 years, even if LRP payments are reduced to zero after 15 years. This provision ensures continued production throughout the contract term. If an agency fails to comply with these provisions, Metropolitan may require reimbursement for a percentage of the previous LRP payments toward that project. The reimbursement would be determined for each year remaining in the agreement considering the following:

- Previous LRP payments
- Previous project production
- Project production in the year in which a reimbursement is required

Alternative 3 – Fixed Incentive Over 25 Years

Compared to sliding scale incentives that are dependent on Metropolitan's water rate, a fixed incentive rate provides agencies with a more stable source of funds to help address financing issues. Metropolitan would offer a project-specific fixed incentive rate up to \$305/AF over 25 years. The fixed incentive amount for each project would be negotiated so that Metropolitan's maximum obligation toward a project under this alternative would not exceed 90% of the estimated financial obligations under Alternative 1 for the same project. In addition to the general requirements and performance provisions, the following provision would apply to this alternative: Total LRP payments under the agreement term would be limited to total estimated project yield presented by the agency at the time of agreement negotiation.

IRVINE RANCH WATER DISTRICT POLICY POSITION UPDATES TO METROPOLITAN WATER DISTRICT'S LOCAL RESOURCES PROGRAM DRAFT

September 10, 2018

Issue Summary:

Metropolitan Water District of Southern California (Metropolitan) encourages the development of local water resources in its service area through the implementation of the Local Resources Program (LRP). This program provides incentives to water agencies for the development of water recycling, groundwater recovery and seawater desalination projects that offset a demand or prevent adding a new demand on Metropolitan for imported water supplies. The development of local water supplies is seen by Metropolitan as a way to reduce the need to increase imported water supplies. The incentive program also indirectly increases regional water supply reliability, decreases the burden on Metropolitan's infrastructure, reduces costs and frees up conveyance capacity in Metropolitan's system.

Metropolitan is considering making revisions to its Local Resources Program to deal with both near-term and long-term policy issues that are interrelated to its Integrated Resources Plan. The Municipal Water District of Orange County is engaged with Metropolitan in the policy discussions and seeking input from its member agencies on the issues. To help guide IRWD's advocacy efforts related to the ongoing LRP discussions, staff has prepared this Policy Position Paper.

Background:

In 2014, Metropolitan issued guidelines for agencies to use when applying for LRP incentives for water recycling, groundwater recovery, and seawater desalination projects. These guidelines provide details on the program, general requirements and the application process. In July 2017, Metropolitan adopted policy principles that guide Metropolitan's role in regional implementation of Integrated Water Resources Plan targets for local resources. These principles identify that Metropolitan should have multiple approaches for developing local resources in cooperation with other agencies. To date, the LRP program remains the primary method that Metropolitan utilizes to encourage local water resource development.

Currently, Metropolitan offers three LRP incentive payment structures for the development of water recycling, groundwater recovery, and seawater desalination projects. The three options are described as follows:

- Option 1: Sliding scale incentives up to \$340 per acre-foot over 25 years;
- Option 2: Sliding scale incentives up to \$475 per acre-foot over 15 years; or
- Option 3: Fixed incentives up to \$305 per acre-foot over 25 years.

Sliding scale payments are based on actual project unit costs that exceed Metropolitan's prevailing Full Service Tier-1 Treated Water Rate. Fixed incentives are negotiated such that Metropolitan's maximum obligation would not exceed 90% of Metropolitan's commitment to provide funding under Option 1. LRP incentives remain contingent upon the approval of the Metropolitan Board of Directors.

There are numerous opportunities that are available to Metropolitan to update its LRP and to develop new approaches to encourage local resource development. The following policy principles provide a basis for IRWD's advocacy for making such improvements and for developing new approaches.

Policy Principles:

- 1. Metropolitan should consider the needs of its member agencies in implementing incentive programs other than the LRP to encourage water supply projects located both in and outside of Metropolitan's service area that improve the water supply reliability of Metropolitan and its member agencies.
- 2. Metropolitan should establish criteria for prioritizing LRP incentives to local resource projects in areas with reduced water supply reliability as compared to other areas of Metropolitan's service area (e.g., South Orange County and the northern areas of Metropolitan's service area). Such criteria should ensure regional supply benefits while addressing local supply reliability issues.
- 3. LRP funding should not be provided to projects that result in local communities subsidizing other areas of Metropolitan's service area. Such reverse subsidization occurs whenever LRP incentives are unable, within a short period of time, to bring the cost of water down to the Full Service Tier-1 Treated Rate offered by Metropolitan.
- 4. LRP funding should not result in significant impacts to Metropolitan treatment facilities. Any such impacts should be justified through an actual improvement in local agency water supply reliability rather than just simply replacing one supply for another.
- 5. LRP funding should also be offered to agencies for projects that will result in reductions in demands for untreated water from Metropolitan with incentives being provided down to the cost of Full Service Tier-1 Untreated Rate offered by Metropolitan such as recycled water storage projects.
- 6. Metropolitan should index its LRP incentives to inflation to improve the feasibility and life cycle costs of local resource projects.
- 7. Metropolitan should expand the LRP or develop other incentives programs to encourage storm water and urban runoff capture and reuse projects that do not result in reductions in supplies to others.
- 8. A new incentive program should be implemented by Metropolitan that promotes development of extraordinary supplies from projects located outside Metropolitan's service area. Such projects can reduce Metropolitan's need to improve the reliability of its imported supplies by augmenting supplies during periods of droughts, emergencies and water supply allocations. Metropolitan incentives would be paid at the time water from such a project is imported to Metropolitan's service area for use by the local agency.

- 9. Incentives should be provided to fund large "on-site" reuse projects that defer or avoid Metropolitan's capital and/or operational costs. Such incentives could be provided to customers such as large-scale industrial facilities where the feasibility of implementing on-site reuse projects depends on receiving incentive funding.
- 10. Metropolitan should provide LRP incentives to desalination projects through separate funding initiatives that do not impair the ability of non-desalination related local projects to receive funding under existing Metropolitan limits for LRP investments.

EXHIBIT "C" Policy Principles Adopted by Metropolitan in July 2017

Proposed Policy Principles

Recommended Policy Principles guiding Metropolitan's role in regional implementation of Integrated Water Resources Plan targets for local resources and conservation

- 1. Metropolitan should take an active role in identifying and evaluating local resource and conservation opportunities within its service area.
- 2. Metropolitan should have multiple approaches and avenues available for developing and implementing local resources and conservation in cooperation with local agencies and entities.
- 3. Metropolitan should evaluate the feasibility and effectiveness of direct investment and development of regionally beneficial local resources and conservation where appropriate.
- 4. Metropolitan should include the consideration of sustaining and/or recovering production from existing projects and programs in its approaches to developing local resources and conservation.
- 5. Evaluations of regional investments in local resources and conservation should, at a minimum, include consideration of:
 - Type and source of water supply
 - Measurable water supply yield or demand reduction
 - Impacts, positive or negative, to Metropolitan system redundancy or emergency risk
 - Impacts, positive or negative, to existing Metropolitan system investments and developed system capacity
 - Total cost elements
 - Metropolitan financial exposure and revenue recovery
- 6. Metropolitan's operational and administrative policies should not adversely impact regional efforts to develop local resources and conservation.
- 7. State and federal mandates should not impact Metropolitan's participation in local resource and conservation development provided that the effect of the mandate is consistent with regional IRP targets.
