MINUTES OF REGULAR MEETING – JULY 22, 2019

The regular meeting of the Board of Directors of the Irvine Ranch Water District (IRWD) was called to order at 5:00 p.m. by President LaMar on July 22, 2019 in the District office, 15600 Sand Canyon Avenue, Irvine, California.

PUBLIC HEARING

SEWER CHARGES IN THE IRWD NEWPORT NORTH AREA

President LaMar declared it to be the time and place for the hearing on the sewer charge report for the Newport North area, and declared the hearing open. He asked the Secretary to report the manner by which the Notice of Hearing was given.

Secretary Bonkowski said that the report was filed with the Secretary on July 5, 2019, and notice of this hearing was published in the Newport Beach-Costa Mesa Daily Pilot on July 6 and July 13, 2019, and posted in the District office on July 5, 2019. She then presented an Affidavit of Posting and the Proof of Publication for the Board to receive and file.

On <u>MOTION</u> by Matheis, seconded by Reinhart, THE AFFIDAVIT OF POSTING AND THE PROOF OF PUBLICATION PRESENTED BY THE SECRETARY WAS RECEIVED AND FILED.

2019 LEGISLATIVE AND REGULATORY UPDATE

Director Reinhart asked that key bills be summarized to include IRWD goals and what is to be achieved from these bills. President LaMar suggested that these updates be included in the General Manager's Weekly Report to the Board. There being no further discussion, on <u>MOTION</u> by Matheis, seconded by Withers and unanimously carried, THE BOARD ADOPTED A "WATCH" POSITION ON AB 217 (GARCIA).

ACTION CALENDAR (CONTINUED)

CONSTRUCTION INSPECTION SERVICES AGREEMENT

General Manager Cook reported that the current construction inspection workload for capital, development and operational improvement projects continues to exceed a level that can be supported by the District's inspection staff of eight staff inspectors and five consultant inspectors who are currently responsible for inspection, field coordination, documentation and record drawing preparation for over 530 projects throughout the District. He said that based on currently active and upcoming construction projects planned by the major developers including Irvine Company, FivePoint Communities, Lennar and the City of Tustin, staff anticipates the need for continued consultant field inspection support for a period of up to two years.

Mr. Cook said that NV5 is currently providing two experienced inspectors under its contract who have worked well within the District's inspection group and have demonstrated the ability to inspect and coordinate multiple projects simultaneously. As funds for the current agreement with NV5 will be expended by August 2019, staff requests a new Professional Services Agreement for continued inspection services.

On <u>MOTION</u> by Reinhart, seconded by Matheis, THE BOARD AUTHORIZED THE GENERAL MANAGER TO EXECUTE A PROFESSIONAL SERVICES AGREEMENT WITH NV5 IN THE AMOUNT OF \$1,332,800 FOR CONSTRUCTION INSPECTION SERVICES FOR TWO INSPECTORS FOR A TWO-YEAR PERIOD.

2019 SHORT-TERM WATER EXCHANGE PROGRAM WITH CENTRAL COAST WATER AUTHORITY

Using a PowerPoint presentation, Ms. Natalie Palacio highlighted the agreement terms with Carpinteria Valley Water District (CVWD) through the Central Coast Water Authority including: 1) a 2-for-1 exchange of 700 acre-feet of State Water Project water from Carpinteria Valley Water District (CVWD); 2) delivery prior to the end of 2019; 3) CVWD's share would be returned by the sixth year; 4) losses and variable would be shared equally; and 5) that the recharge and recovery priorities would be coordinated with other IRWD water banking programs. She further reviewed the projected deliveries to IRWD's water bank, and reviewed the annual recharge capacities.

Director Reinhart reported that this item was reviewed and approved by the Supply Reliability Programs Committee on November 15, 2018. On <u>MOTION</u> by Reinhart, seconded by Matheis and unanimously carried, THE BOARD AUTHORIZED THE GENERAL MANAGER TO EXECUTE THE LETTER AGREEMENT FOR A 2019 SHORT-TERM WATER EXCHANGE PROGRAM WITH CENTRAL COAST WATER AUTHORITY SUBJECT TO SUBSTANTIVE CHANGES APPROVED BY THE SUPPLY RELIABILITY PROGRAMS COMMITTEE AND SPECIAL LEGAL COUNSEL.

ACTION CALENDAR (CONTINUED)

SYPHON RESERVOIR IMPROVEMENTS PROJECT GEOTECHNICAL INVESTIGATION SERVICES CONSULTANT SELECTION

Executive Director of Technical Services Burton reported that the proposed geotechnical investigation will provide for a comprehensive site characterization program to adequately document and characterize the geologic and geotechnical conditions at the site. Mr. Burton said that the proposed investigation will evaluate the dam foundation and abutments to determine the appropriate excavation depths and requirements for dam seepage control measures, evaluate the characteristics of potential dam construction materials that could be extracted from borrow areas on the project site, and verify the location and historical activity of the previously documented inactive Center Valley Fault that is believed to be located at or near the reservoir site.

Mr. Burton said to accomplish these goals, the work will involve a combination of exploratory test pits, soil borings, and geophysical surveys to characterize the subsurface conditions of the soil at each exploratory location. Prior to the start of these activities, the reservoir will be drained to allow the reservoir bottom to dry out so that the borings, test pits, and trenches can be implemented more easily. The exploration locations were selected based on the location of the proposed reservoir improvements, access considerations, and the desire to avoid environmentally sensitive areas. The results of the investigation will inform the ongoing environmental documentation process and the future final design phase of the proposed Syphon Reservoir Improvement project.

Mr. Burton said that staff received proposals from AECOM Technical Services, GEI Consultants, the team of GeoPentech/NMG Geotechnical, and the team of Kleinfelder/Stantec, and that each firm presented unique project approaches and creative engineering solutions for achieving the project objectives, but AECOM's approach to completing the project exceeded that presented by the other firms. AECOM outlined a focused and detailed work plan for completing the geotechnical investigation and presented an innovative approach to sequencing the investigation to ensure completion within the project schedule constraints. AECOM also established a superior depth and knowledge of managing and implementing complex geotechnical investigations for reservoir projects.

Mr. Burton said that the Syphon Reservoir Improvements, Project 03808, is included in the FY 2019-20 Capital Budget as a flagged project, and that staff is requesting an additional Expenditure Authorization in the amount of \$2,500,000 to fund the geotechnical investigative work.

Director Reinhart said that this item was reviewed and approved by the Engineering and Operations Committee on July 16, 2019. Following discussion, on MOTION by Reinhart, seconded by Matheis, and unanimously carried, THE BOARD APPROVED AN EXPENDITURE AUTHORIZATION IN THE AMOUNT OF \$2,500,000 AND AUTHORIZED THE GENERAL MANAGER TO EXECUTE A PROFESSIONAL SERVICES AGREEMENT WITH AECOM TECHNICAL SERVICES, INC. IN THE AMOUNT OF \$2,388,838 FOR GEOTECHNICAL INVESTIGATION SERVICES FOR THE SYPHON RESERVOIR IMPROVEMENTS, PROJECT 03808.

JOINT POWERS AUTHORITY AGREEMENT FOR THE KERN FAN GROUNDWATER STORAGE PROJECT

Using a PowerPoint presentation, Director of Water Resources Sanchez reported that the California Water Commission administers Proposition 1 Water Quality, Supply and Infrastructure Project grant funding and dedicated \$2.6 billion in funding for eligible water storage projects providing public benefit which funds a maximum of 50% of capital costs.

Ms. Sanchez reviewed the Kern Fan Groundwater Storage Project highlights, which include: 1) new conveyance from the California aqueduct; 2) 1,050 acres of recharge basins; 3) 12 recovery wells; 4) storage of water otherwise lost to the ocean; and 5) improving flexibility in operation of the State's water system. She then reviewed the key agreement provisions which include: 1) a 30-year term or as required by grant conditions; 2) Rosedale Rio Bravo Storage District (Rosedale) to operate, maintain and repair Kern Fan Project facilities; 3) grant funding will be applied to eligible capital costs with other costs equally funded by IRWD and Rosedale; 4) 100,000 acre-feet per year of recharge capacity, 50,000 acre-feet of recovery capacity and up to 500 cfs of conveyance; 5) 100,000 acre-feet of water storage capacity will be allocated to the Water Storage Investment Program's ecosystem account; 6) first priority access to own respective capacity with second priority access to each other's unused capacity; 7) IRWD and Rosedale to equally fund acquisition and recharge of unallocated State Water Project Article 21 water when available until ecosystem account is full; 8) once the ecosystem account is full, IRWD and Rosedale may fill their accounts with other available water; 9) Kern River Flood water deliveries; 10) governance authority; 11) disposition of property; and 12) indemnification.

Director Reinhart said that this item was reviewed with the Supply Reliability Programs Committee at multiple meetings, most recently on July 18, 2019, and thanked Director Matheis for attending in Director Swan's absence. Following discussion, on MOTION by Reinhart, seconded by Matheis and unanimously carried, THE BOARD AUTHORIZED THE GENERAL MANAGER TO EXECUTE THE JOINT POWERS AGREEMENT BETWEEN ROSEDALE-RIO BRAVO WATER STORAGE DISTRICT AND IRVINE RANCH WATER DISTRICT CREATING THE KERN FAN JOINT POWERS AUTHORITY TO DEVELOP AND ADMINISTER A KERN FAN GROUNDWATER STORAGE PROJECT SUBJECT TO NON-SUBSTANTIVE CHANGES AND THE GENERAL MANAGER'S DETERMINATION THAT REASONABLE ASSURANCES ARE IN PLACE THAT NECESSARY AGREEMENTS WITH THE STATE OF CALIFORNIA RELATED TO THE KERN FAN PROJECT ARE FEASIBLE.

GENERAL MANAGER'S REPORT

General Manager Cook reported that staff will be participating with OCWD on a planning study on the PFAS issue. Additionally, he said that this item will discussed at the August 8, 2019, Strategic Planning Workshop.

Director Reinhart made a correction on his meetings noting that he did attend the July 3, 2019 OCWD Board meeting. He further reported that he attended an OCWD Water Issues Meeting, a MWDOC Administration and Finance Committee meeting, a WACO monthly meeting, a MWDOC Board meeting and a Southern California Water Coalition Quarterly lunch meeting in Carlsbad.

Director Withers reported that he will be attending an OCSD Board meeting this Wednesday as well as an OCSD Centrifuge Facility Ribbon Cutting this Saturday.

Director Matheis reported on her attendance at an IRWD briefing with Councilmember Farrah Khan and her staff, and a community leaders briefing this morning with Congressman Harley Rouda.

Director LaMar reported on his attendance at ACWA's first resiliency workshop, an ACWA Steering Committee meeting, a San Diego Water Authority luncheon meeting, and a Southern California Wafer Coalition Board and lunch meeting.

CONSENT CALENDAR

2019 LEGISLATIVE AND REGULATORY UPDATE

SUMMARY:

This report provides an update on the 2019-2020 legislative session and IRWD priorities. As legislation and regulations develop, staff will provide updates and recommendations to the Water Resources Policy and Communications Committee and the Board, as appropriate.

Staff recommends that the Board receive and file the report.

BACKGROUND:

The California State Assembly and Senate will return from summer recess on August 12, 2019. With one month left in the first year of the 2019-2020 Regular Legislative Session after the Legislature returns, fiscal committees have until August 30 to meet and report bills to the floor. The last day for each house to pass bills in this year is September 13, which is the day the interim legislative recess begins. The Governor has until October 13 to sign or veto legislation passed by the Legislature this session. The 2019-2020 Regular Legislative Session will resume on January 6, 2020.

A copy of the 2019 Legislative Matrix is attached as Exhibit "A". Exhibit "B" is the 2019 Legislative Update Report Links to Bill Texts, which contains links to the bills discussed below.

2019 State Legislative Update:

AB 1486 (Ting, D-San Francisco) – Surplus Land:

AB 1486 would revise the rules related to local agencies' disposal of surplus land. Specifically, the bill would revise the definition of "surplus land" within the Government Code and would restrict local agencies' ability to dispose of surplus land. Under AB 1486, prior to a local agency conducting negotiations to dispose of real property it owns, the local agency must issue a written notice of availability to low- and moderate-income housing providers. This means that prior to negotiating the sale of any property owned by a local agency, a local agency would need to offer the property for housing.

AB 1486 was a reintroduction of a bill Assemblymember Ting ran last year, but this bill has been amended several times as it has moved through the legislative process. A broad coalition of local agencies opposes this bill because it expands the lands which would be subject to the Surplus Land Act, limits the actions a local agency can take when negotiating to dispose of surplus land, and would levy a 50 percent penalty based on the sale price of any land sold in violation of the Surplus Land Act.

Of particular concern to IRWD and the coalition is the definition of "surplus land" and "use" contained in the bill. The bill currently defines surplus land as:

"[L]and owned in fee simple by any local agency for which the local agency's governing body takes formal action in a regular public meeting declaring that the land is surplus and is not necessary for the agency's use. Land shall be-declared either "surplus land" or "exempt surplus land" before a local agency may take any action to dispose of it... Exclusive negotiating agreements or other agreements or contracts for land held in the Community Redevelopment Property Trust Fund shall be subject to this article. Nothing in this article shall be interpreted to require a local agency to dispose of land that is determined to be surplus. Nothing in this article prevents a local agency from obtaining fair market value for the sale or lease of the surplus land consistent with Section 54226."

In conjunction with the "surplus land" definition, the bill defines agency use. The largest concern with the "use" definition currently included in the bill is that it excludes commercial uses or activities, including nongovernmental retail, entertainment, or office development, and property held or disposed of for the sole purpose of investment or generation of revenue.

Because the bill has the potential to impact IRWD's investment and real property transactions, IRWD currently has an "oppose unless amended" position on AB 1486. Staff continues its work to obtain amendments to AB 1486, which will mitigation its impact on the District. Staff will provide an update on any new developments related to this bill.

2019 State Regulatory Update:

Staff continues to track, monitor, and engage in a number of regulations and State agency actions of interest to IRWD. As the next drafts of the regulations or reports are released for public review and comment, staff will engage, as appropriate. Staff will provide an oral update to the Committee on the developments related to regulations of interest to the District, including:

- California Water Plan Update 2018;
- Governor's Executive Order on a Water Resiliency Portfolio;
- Implementation of the "Making Water Conservation a California Way of Life" Legislation;
- State Board Water Resources Control Board's (State Board) Monthly Reporting Regulation; and
- State Board's Water Loss Performance Standards Regulations.

CONSENT CALENDAR

RENEWAL OF GROUP MEDICAL, DENTAL, VISION, AND TERM LIFE INSURANCE FOR CALENDAR YEAR 2020

SUMMARY:

CalPERS Health Benefits Services has notified participating agencies of premium rates for the 2020 plan year beginning January 1, 2020. ACWA/JPIA has negotiated rates for dental insurance coverage with Delta Dental for the plan year beginning January 1, 2020 which results in no change in the premiums for IRWD's current dental plan, DPO Plan A. EyeMed will extend a third year rate guarantee which results in no change in premiums for IRWD's current vision plan. Reliance Standard will extend a fourth year rate guarantee which results in no change in premiums for IRWD's current Term Life and Accidental Death and Dismemberment (AD&D) plan.

ACWA/JPIA and EyeMed have offered IRWD voluntary buy-up plans for both dental and vision insurance, respectively, to provide employees an option to purchase a higher level of dental and/or vision insurance coverage. Staff recommends that the Board authorize staff to:

- Continue health insurance coverage with CalPERS for the calendar year 2020 with changes in District and employee contribution rates;
- Extend IRWD's existing contracts with ACWA/JPIA for Delta Dental DPO Plan A and EyeMed for vision insurance for coverage in calendar year 2020;
- Offer a voluntary buy-up Delta Dental plan from ACWA/JPIA for employee purchase; and
- Offer a voluntary buy-up vision insurance plan from EyeMed for employee purchase.

BACKGROUND:

<u>CalPERS Medical Insurance Renewal Information:</u>

IRWD currently utilizes the CalPERS medical insurance program to provide medical insurance coverage for employees. Each year, in advance of the annual insurance benefit open enrollment period, the District receives the premium rates for each health insurance plan for the upcoming calendar year. The health care rate and plan changes for 2020 include an overall average premium increase of 4.65%. For the 2020 calendar year, CalPERS has notified IRWD of premium rate changes for each of the specific plans from which IRWD employees may choose.

This year CalPERS also announced a new regional premium structure with a new three-region model that will go into effect for public agency and school employers that contract with CalPERS for health insurance. IRWD is located in Region 2, made up of Fresno, Imperial, Inyo, Kern, Kings, Madera, Orange, San Diego, San Luis Obispo, Santa Barbara, Tulare and Ventura counties. The majority of IRWD employees are located in Region 2 and Region 3, which includes San Bernardino, Los Angeles, and Riverside counties. The premiums rates for CalPERS health insurance plans for the 2020 calendar year, for Regions 2 and 3, are shown in Exhibit "A".

Dental Coverage:

IRWD's current employee dental insurance coverage is provided by Delta Dental Plan of California through ACWA/JPIA. IRWD currently contracts through ACWA/JPIA for the DPO Plan A with child and adult orthodontic coverage as an add-on. The ACWA/JPIA negotiated rates with Delta Dental for calendar year 2019, and premiums for the 2020 DPO Plan A with child and adult orthodontic coverage, will remain unchanged from 2019 rates.

IRWD's current monthly rates are \$35.36 for "employee only" coverage, \$69.99 for "employee plus+1" coverage and \$128.10 for "family" coverage. These premium rates include the ACWA/JPIA administration fee of \$2.24 per enrollee per month.

For the 2020 coverage year, ACWA/JPIA is also offering IRWD a Delta Dental voluntary employee purchase buy-up plan as an additional dental insurance option for District staff. This voluntary plan will provide enhanced dental benefits for employees who choose to purchase this plan. The cost of the buy-up plan to the employee is recommended to be the difference between the premium cost the District currently pays for dental coverage and the cost of the buy-up plan premiums. The buy-up plan provides 100% coverage for exams, x-rays and cleanings, up from 85% (in-network) and 80% (out-of-network) for the District-paid plan and increases the per person maximum annual coverage to \$2000, up from \$1500 for the District-paid plan. The employee costs for the buy-up plan are shown in Exhibit "B".

Vision Coverage:

IRWD's current employee vision insurance coverage is provided by EyeMed. IRWD negotiated rates with EyeMed for calendar year 2019, and premiums for the 2020 vision plan will remain unchanged from 2019 rates. IRWD's current monthly rates are \$8.69 for "employee only" coverage, \$16.52 for "employee plus+1" coverage and \$24.23 for "family" coverage.

For the 2020 coverage year, EyeMed is offering the District a voluntary employee purchase buy-up plan as an additional vision insurance plan option for District staff. This voluntary plan will provide enhanced vision benefits for employees who choose to purchase this plan. The cost of the buy-up plan to the employee is recommended to be the difference between the premium cost the District currently pays for vision coverage and the cost of the buy-up plan premiums. The buy-up plan removes the \$10 exam co-pay that is present in the District-paid plan and provides for 40% greater coverage for frames and 30% greater coverage for contact lenses than the District-paid plan. The employee costs for the buy-up plan are shown in Exhibit "C".

Term Life and AD&D Insurance Coverage:

IRWD's current employee Term Life and AD&D insurance coverage is provided by Reliance Standard. IRWD negotiated rates with Reliance Standard in 2017, which included a rate guarantee through December 2019. Reliance Standard has agreed to continue the rate guarantee for the 2020 plan year. Premium rates remain unchanged from the 2017 rates.

Open Enrollment Process for 2020:

The CalPERS 2020 health insurance open enrollment period is scheduled for September 9, 2019 through October 4, 2019. Staff will conduct employee open enrollment informational meetings in mid- to late-August. Health insurance plan representatives have been invited to attend the IRWD Employee Health and Wellness Fairs which will be held at the Michelson Operations Center on September 4, 2019, and at the Sand Canyon Headquarters facility on September 16, 2019.

Employer Health Insurance Contribution Rates:

IRWD has a long-standing practice of calculating the employer and employee contribution rates for health insurance premiums based on rates of the Preferred Provider Organization (PPO) plan offered which had the highest enrollment in the prior renewal year. The rates for that plan are then used to calculate the maximum District contribution rates for all plans offered.

In 2019, the year prior to this 2020 renewal, the PPO plan offered with the highest enrollment was the PERS Choice-PPO – Other Southern California Region (OSC) plan. The premium for this plan will increase 2.1% for the 2020 renewal, resulting in an increase to the District's maximum contribution rates, to align with the higher 2020 PERS Choice-PPO plan premiums.

CalPERS Administrative Fees and Reserves:

On June 26, 2019, the CalPERS administrative fee was set at 0.27 percent for fiscal year dating July 1, 2019 to June 30, 2020. The administrative fee yielded an increase from the prior year of 0.23%. The administrative fee is calculated on total active and retired gross health premiums and billed to contracting agencies monthly. While CalPERS can also charge up to 4% for a contingency reserve fund, a contingency fee has not been assessed since 1985. For 2020, IRWD has not been notified of any contingency reserve fees.

FISCAL IMPACTS:

Continuation of the CalPERS medical insurance plans will result in total projected expenses for FY 2019-20 of \$6,331,988, approximately 93.4% of the \$6,775,227 budgeted for this item. Actual District medical insurance expenses for FY 2018-19 was \$5,910,302, which represents a 7.2% (\$421,686) increase over 2018-19 budget for this item due to a smaller vacancy factor than what was projected for the FY 2018-19 fiscal year.

Renewal of the ACWA/JPIA for Delta Dental DPO Plan A will result in no change in premium rates. Annual dental insurance premium rates for FY 2019-20 will be approximately \$438,000, which is 88% of the amount budgeted of \$498,798.

Renewal of the EyeMed Vision plan will result in no change in premium rates. Annual vision insurance premium rates for FY 2019-20 will be approximately \$87,000, which is 95% of the budgeted amount of \$90,932.

Renewal of Reliance Standard Term Life and AD&D plan will result in no change in premium rates. Annual Term Life and AD&D insurance premium rates for FY 2019-20 will be approximately \$344,000, which is 96% of the budgeted amount of \$354,212.

SAND CANYON PROFESSIONAL CENTER PHASE II PROFESSIONAL SERVICES VARIANCE NO. 5

SUMMARY:

The Sand Canyon Professional Center Phase II project includes construction of a 70,000-square-foot for-lease office building and a central outdoor area adjacent to the District's Sand Canyon Headquarters building. In December 2015, the District retained Ware Malcomb to provide architectural services for the project. This project is currently under construction. Staff recommends that the Board authorize the General Manager to execute a Professional Services Variance in the amount of \$21,700 with Ware Malcomb for additional architectural service for Project No. 06210.

BACKGROUND:

Phase II of the Sand Canyon Professional Center includes construction of an approximate 70,000-square-foot professional office building, related site work, and completion of a central outdoor area adjacent to the IRWD Headquarters facility. In December 2015, the District retained Ware Malcomb to serve as the project architect for the amount of \$419,000. Building plans were originally submitted to the City of Irvine in October 2016 and then resubmitted in April 2018. Following plan approval, construction commenced in January 2019. Previously approved variances included the following additional work:

Variance No. 1: Revisions and re-submittal of the building and landscape plans required by the City to comply with updated building codes (\$53,000);

Variance No. 2: Coordination with the City and the Irvine Company related to required lot line adjustments, Water Quality Management Plan and landscape architect revisions (\$15,148);

Variance No. 3: Additional engineering design revisions required by the City (\$32,000); and

Variance No. 4: Plan redesign of hardscape, landscape and irrigation to incorporate new EV charging stations installed in the District's parking area following plan approval (\$8,600).

<u>Professional Services Agreement Variance No. 5:</u>

Ware Malcomb has provided an "Add Service" request for additional site revisions in the amount of \$21,700, which include necessary modifications to architectural, plumbing, electrical and landscape plans including:

• Remove garden wall in the lobby area and fire bowl at building front entrance area;

• Modify outdoor lighting, including engineering for light pole foundations;

- Provide additional electrical and gas meters to the building, and power access to the outdoor counter area, various locations in the courtyard, and the rooftop deck;
- Relocate the primary gas meter to the northeast end of the building; and
- Relocate point of connection for recycled water.

The amount due for the additional design services is \$21,700. Staff and the District's construction manager, Newport Real Estate Services, have reviewed the variance request items and determined that the request is appropriate. Ware Malcomb's "Add Service" request is attached as Exhibit "A".

FISCAL IMPACTS:

In December 2015, the Board authorized the General Manager to award a Professional Services Agreement to Ware Malcomb for architectural services in the amount of \$419,000. The current variance request will bring the contract with Ware Malcomb to \$549,448 for architectural services for Project No. 06210.

ENVIRONMENTAL COMPLIANCE:

A Final Environmental Impact Report has been prepared, certified and the project approved by the County of Orange Environmental Management Agency in compliance with the California Environmental Quality Act (CEQA) of 1970 (as amended), codified at California Public Resources Code Sections 21000 et. seq., and the State CEQA Guidelines in the Code of Regulations, Title 14, Division 6, Chapter 3.

METER READING AND ELECTRONIC BILLING CONTRACT VARIANCES

SUMMARY:

Two five-year Professional Services Agreements previously authorized by the Board are both in their final year and will exceed their authorized amounts in Fiscal Year 2019-20. Fiserv Solutions, LLC provides electronic billing (eBill) services for the distribution of customer bills in an electronic format and for on-line and on-demand electronic payments. Fiserv's original contract amount was for \$900,000 and a variance in the amount of \$197,000 is now needed to continue services through FY 2019-20. Alexander's Contract Services provides meter reading services of the vast majority of IRWD's customer meters. Alexander's original contract amount was for \$6,534,000 and a variance in the amount of \$394,000 is now needed to continue services through FY 2019-20. Staff recommends that the Board authorize the General Manager to execute a variance to the Fiserv agreement in the amount of \$197,000 and a variance to the Alexander's agreement in the amount of \$394,000.

BACKGROUND:

Variance for Fisery Solutions, LLC:

In August 2015, the Board approved a five-year agreement with Fiserv in the amount of \$900,000 based on the number of eBill customers at that time. Since 2015, eBill enrollment and use of on-line and on-demand services has increased substantially. The original Board-approved agreement amount was based on enrollment of approximately 47,000 District customers, which was 43% of IRWD's 111,000 utility billing accounts. Enrollment has grown, with current enrollment at approximately 64,000, or 51%, of 125,000 utility billing accounts. The following is a summary of Fiserv's past and future expenditures anticipated through the end of the current five-year agreement:

Variance for Alexander's Contract Services:

In July 2015, the Board approved a five-year contract for meter reading services with Alexander's in the amount of \$1,306,800 per year, for a total of approximately \$6,534,000. This original contract amount was based on the number of meters at that time. Meter reading services are provided at a fixed cost per meter. As IRWD's service area has continued to develop, the number of meters to be read has increased as well. The original agreement with Alexander's was based on approximately 109,000 meters; IRWD now has approximately 122,000 customer meters. The following is a summary of Alexander's past and future expenditures anticipated through the end of the five-year contract:

2019 WATER USE EFFICIENCY OUTREACH CAMPAIGN

SUMMARY:

Staff proposes a 2019 water use efficiency outreach campaign comprised of several small targeted customer outreach efforts to help sustain customer water use awareness and to thank customers for their continued vigilance in using water efficiently. The efforts will also assist staff in baseline customer outreach activities involving newsletters, social media and ongoing community outreach workshops and events. Staff recommends the Board authorize the General Manager to execute a Professional Services Agreement with Sukle Advertising & Design in the amount of \$214,500 for implementation of the 2019 water use efficiency outreach campaign.

BACKGROUND:

In 2017 and 2018, IRWD implemented a two-year water use efficiency outreach campaign focused on reducing outdoor watering among residential customers. The goal of the campaign was to sustain the water use reductions achieved during the 2016 drought and to seek additional savings by customers who have a history of exceeding their water budget. At the conclusion of these efforts, staff compiled water use statistics and determined that there was a small reduction in residential water use attributable to the 2018 campaign.

While the customer focus groups and surveys that were implemented each year during the two-year campaign indicated that IRWD's customers continue to consider outdoor water use efficiency important, these same studies concluded that customers are underestimating the proportion of water they are using outside. The studies also concluded that customers may believe they are being more efficient at using water than they actually are. This, coupled with message fatigue and a reduction in the urgency to save water as drought conditions have abated in California, has resulted in a challenging environment for affecting real change in residential customer water use habits.

Future Potential Water Efficiency Study:

In November 2018, the Board approved a Professional Services Agreement with EKI Environment & Water to conduct a study of IRWD's Future Potential Water Efficiency. This study will identify opportunities for future water savings. The results of this study are expected to be available in late September. The study results will be used to design targeted water efficiency programs and to inform associated future comprehensive outreach campaigns.

2019 Targeted Outreach Campaign:

While the results of the EKI water efficiency study are being developed and analyzed, staff recommends the implementation of several small targeted outreach efforts that will comprise a campaign to continue to sustain customer awareness and to assist staff in baseline outreach

activities involving newsletters, social media and ongoing community outreach workshops and events. To assist with the development and implementation of the campaign, staff recommends that IRWD execute a Professional Services Agreement with Sukle Advertising & Design.

Outreach Campaign Scope of Work:

Sukle proposes to implement the "Don't Waste a Good Thing" campaign and to lead the development of several targeting outreach efforts. Sukle will also develop a 2020 campaign plan as described in the scope of work provided as Exhibit "A". The following table provides the total not-to-exceed costs for tasks that will be billed by Sukle on a time and material basis.

SITUATION

Irvine Ranch Water District has approved a new tagline. "Don't waste a good thing" is the rallying cry that all IRWD customers can get behind. The tagline speaks to the quality of IRWD water, its inherent value and encourages water efficient behavior. It will be used to connect a variety of IRWD messages over time.

This plan outlines how we will begin to roll out the idea to the IRWD community in 2019, supplemented by other key initiatives.

Q3/Q4 2019

1. "DON'T WASTE A GOOD THING" LAUNCH

Foundational Elements

The tagline should be applied to all IRWD assets to create consistent messaging across all communication efforts. The agency will design each element and create art files. For some tactics, the agency will pass off art files to the client to apply the new tagline.

Deliverables include:

- IRWD logo/tagline lock up art files
- 2 to 3-page logo/tagline standards document
- Email signatures
- Redesign Pipeline customer newsletter template to be specific for WUE efforts incorporating "Don't waste a good thing" assets – includes updating the "Ask Juan" graphics
- IRWD vehicle design
- IRWD shirt design

Timing: 2-4 weeks Budget: \$25,000

Social Media Campaign

This campaign will begin to seed the message of a "Don't waste a good thing" to your customers. It will consist of three social posts (a mix of static and animation) to be used organically and boosted by IRWD.

The ideas generated will be dual-purpose as they will be used to create other assets for IRWD like lobby signage and community TV static advertisements.

Deliverables include:

- "Don't waste a good thing" social ideas
- Design, writing and production of 3 Facebook posts
- 1-2 executions repurposed for lobby screens
- 1-2 static executions repurposed for the community TV channel
- 1-2 executions formatted to print banners (printing will be completed by IRWD)

3. COMMUNITY GRASSROOTS OUTREACH

IRWD Branded Booth

The agency will redesign the IRWD booth to incorporate the new tagline, "Don't waste a good thing." The agency will find a vendor to produce the booth or graphics and will provide production estimates. Upon approval the agency will create final artwork and work with the vendor to produce the materials. It is assumed that the booth will be similar in structure and size to the existing IRWD booth. Removeable graphics panels will be designed and translated into Spanish, Chinese and Korean. The range in budget is due to translations, production and possible graphics or imagery that would be needed as part of the design.

Deliverables include:

- A booth design
- Fabrication
- Removable graphics panels translated into Spanish, Chinese, Korean

Timing: 4-8 weeks Budget: \$23,000-\$28,000

4. GARDEN-WISE CAMPAIGN OUTREACH

The agency will develop messaging and create a consistent look and feel for all elements of the IRWD Garden-Wise outreach materials.

The agency will concept, write and design assets that allow IRWD to promote Garden Workshops in the various communities of the IRWD service area. The promotion will consist of static posts that can be used on social media and for partner organizations on their multi-cultural websites. The agency will also design fresh graphics for various workshops in English on the RightScapeNow website.

Deliverables include:

- 2 static Facebook posts in English
- Provide 6 JPEGs (2 per language) of the static posts for partner organizations
- Translations in Spanish, Chinese and Korean
- 4 graphics for 4 different types of workshops (in English) on the RightScapeNow website

To keep customers engaged beyond the workshops, an eNewsletter would be created and offered to attendees.

The agency will design a Garden-Wise eNewsletter to inform and educate customers about waterwise gardening tips and tricks. The design would be consistent with the look and feel of the redesigned Pipeline WUE eNewsletter so they feel like a suite of templates. The agency will work with IRWD to develop content. The agency will design, write and produce the quarterly publication. It will be translated into Spanish, Chinese and Korean. IRWD would be responsible for deploying the eNewsletters.

Deliverables include:

- A template design
- Copy, images and design for Q4 newsletter
- Translations in Spanish, Chinese and Korean

Timing: 4-6 weeks

Budget: \$15,000 - \$20,000

5. 2020 PLANNING

Based on the findings of the IRWD water efficiency study being conducted, the agency will participate in a planning session with the client and consultants. This session will inform the initiatives for 2020. Based on the outcome of that discussion, the agency will create a written plan for 2020.

Deliverables include:

- Planning session attended by 3 members of the Agency team
- Written plan for 2020
