MINUTES OF REGULAR MEETING –MARCH 13, 2023

The regular meeting of the Board of Directors of the Irvine Ranch Water District (IRWD) was called to order at 5:00 p.m. by President McLaughlin on March 13, 2023 at the District offices, 15600 Sand Canyon Avenue, Irvine.

Also Present: General Manager Cook, Executive Director of Operations Chambers, Executive Director of Finance and Administration Clary, Executive Director of Technical Services Burton, Executive Director of Water Policy Weghorst, Director of Strategic Communications and Advocacy / Deputy General Counsel Compton, Director of Water Resources Sanchez, Director of Recycling Operations Zepeda, Director of Human Resources Mitcham, Director of Water Quality and Regulatory Compliance Colston, Director of Safety and Security Choi, Director of Maintenance Manning, Secretary Bonkowski, Assistant Secretary Swan, General Counsel Collins, and members of the staff and public.

4. COMMUNITY RELATIONS PROGRAM STRATEGIC PLAN

Using a PowerPoint presentation, Community Relations Manager VanDyke presented the IRWD Community Relations Program Strategic Plan. Following the presentation, Director Withers reported that this item was reviewed by the Water Resources Policy and Communication Committee on March 6, 2023 and was well done.

11. LAND USE CLASSIFICATION DATA UPDATE

Water Efficiency Manager McNulty said that the "Conservation as a Way of Life Legislation," enacted in 2018, will require urban water suppliers to comply with and report on agency-specific water budget targets – known as the Water Use Objective – beginning in November 2023. Ms. McNulty said that accurate measurement of irrigable areas is an integral part of calculating the outdoor water use component of the Water Use Objective. The legislation requires the California Department of Water Resources (DWR) to provide residential landscape area measurements to all water suppliers. She said that IRWD staff has observed significant inaccuracies in the measurements provided to the District. IRWD has used aerial imagery, combined with 2016 Land Use Classification (LUC) data, to develop more accurate measurements of irrigable area for IRWD's service area. Since 2016, DWR has modified the algorithms used to classify landscape area and IRWD has grown significantly. As a result,

IRWD's LUC data needs to be updated, and would provide additional benefits to the District, such as improving the ability to target outdoor water efficiency programs and assessing landscape transformation between data sets.

Ms. McNulty said that Eagle Aerial is uniquely qualified, as a sole source vendor, to provide IRWD with updated LUC data. Eagle Aerial and Quantum Spatial conducted the state-wide analysis for DWR and developed the algorithms to classify land use cover based on DWR standards. Eagle Aerial also worked with IRWD to prepare the initial aerial imagery and LUC data that was the foundation of the Meter to Parcel Project. They also customized the process to IRWD's requirements. Other firms offer remote sensing analysis services but cannot provide LUC data that is aligned with DWR's landscape classification methodology. In updating IRWD's LUC data, Eagle Aerial would partner with NV5 (formerly Quantum Spatial), with NV5 serving as a sub-consultant.

Director Withers said that this item was reviewed at the March 6, 2023, Water Resources Policy and Communications Committee meeting. On <u>MOTION</u> by Withers, seconded and unanimously carried, THE BOARD AUTHORIZED THE GENERAL MANAGER TO EXECUTE A PROFESSIONAL SERVICES AGREEMENT WITH EAGLE AERIAL SOLUTIONS AS A SOLE SOURCE IN THE AMOUNT OF \$221,646 TO UPDATE IRWD'S LAND USE CLASSIFICATION DATA.

12. TERMS FOR PILOT WATER MANAGEMENT PROGRAM WITH HOMER LLC

Using a PowerPoint presentation, Water Resources Manager Welch reported that the California Department of Water Resources (DWR) is expected to make Article 21 water available to the State Water Project (SWP) Contractors in the coming weeks and that IRWD will have access to Article 21 water through its ownership of land in the Dudley Ridge Water District but will likely not have access to the Cross Valley Canal (CVC) to deliver the water to IRWD's Water Bank.

Ms. Welch said that Homer LLC is a landowner in Berrenda Mesa Water District with the right to use SWP water and also has the right to 217 cubic feet per second (cfs) of CVC capacity in Kern County that exceeds Homer's needs. She said that IRWD has the right to 4.87 cfs of CVC conveyance capacity and relies on Rosedale-Rio Bravo Water Storage District to deliver IRWD and its partners water in the CVC using Rosedale's excess CVC capacity. In wet years, Rosedale may not have excess capacity to convey IRWD's Article 21 water in the CVC. She said that over the past year, staff explored with Homer the possibility of implementing a mutually beneficial water management program. The proposed program would allow Homer to deliver water into the IRWD Water Bank on a 1-for-1 basis with IRWD being compensated with access to Homer's CVC capacity during periods when IRWD would otherwise not be able to deliver its own water into the IRWD Water Bank. She said to facilitate IRWD's urgent need for access to Homer's CVC capacity, staff has prepared the mutually beneficial draft terms for a Pilot Water Management Program.

On <u>MOTION</u> by Reinhart, seconded by Withers and unanimously carried, THE BOARD AUTHORIZED THE GENERAL MANAGER TO EXECUTE A LETTER AGREEMENT FOR A PILOT WATER MANAGEMENT PROGRAM WITH HOMER LLC BASED ON THE TERMS PRESENTED.

13. GENERAL MANAGER'S REPORT

Due to the recent rain events, General Manager Cook reported on the reservoir status for Irvine Lake and the Sand Canyon Reservoir and said that water is continuing to be diverted to the Green Acres Project.

Mr. Cook reported on a meeting held last week with Second Harvest. The District may be able to accommodate its request for land to grow food in containers, either at the MWRP or on IRWD property in Lake Forest.

Mr. Cook reported that he attended a WateReuse Symposium in Atlanta last week where IRWD, along with Discovery Cube, received an award in the category of Outreach and Education.

14. **COMMUNITY UPDATES**

Mr. Cook said that consultant Newell did not have a community update this evening as he was deployed to San Bernardino assessing structures that have been impacted by heavy snow.

15. **DIRECTORS' COMMENTS**

Director Withers said that he attended meetings on the list and also noted upcoming meetings he will attend including the Santiago Aqueduct Commission meeting and a Lake Forest State of the City address this week.

Director Reinhart said that he attended meetings on the list except for the OCWD Board meeting. He also said he attended a MWDOC Board meeting.

Director McLaughlin said that she attended the meetings on the list with the exception of the monthly WACO meeting.

President McLaughlin adjourned the meeting at 5:51 p.m.

FISCAL IMPACTS:

As of February 28, 2023, the book value of the investment portfolio was \$370,650,001, with a 2.71% rate of return and a market value of \$365,530,044. Based on IRWD's December 31, 2022, quarterly real estate investment rate of return of 13.02%, the weighted average return for the fixed income and real estate investments was 4.85%.

As of February 28, 2023, the outstanding principal amount of fixed and variable rate debt was \$610,630,000. The monthly weighted average all-in variable rate was 2.82%. Including IRWD's weighted average fixed rate bond issues of 3.71% and the negative cash accruals from fixed payer interest rate swaps, which hedge a portion of the District's variable rate debt, the total average debt rate was 3.50%.

Payroll ACH payments totaled \$2,468,704 and wire transfers, all other ACH payments, and checks issued for debt service, accounts payable, payroll, water purchases, and voided checks for February totaled \$20,300,121.







TRUCK-MOUNTED CRANE PURCHASE

SUMMARY:

Truck-mounted cranes are used by IRWD staff during construction and maintenance activities to lift heavy supplies and equipment safely. Truck-mounted cranes provide flexibility, improve productivity, and enhance worker safety as they can be used when working within roadways and at worksites throughout the District's service area. Staff recommends that the Board authorize the General Manager to execute a purchase order with Altec Industries, Inc. in the amount of \$414,646 for the purchase of one new truck-mounted crane to replace an existing similar unit.

BACKGROUND:

Staff uses truck-mounted cranes to lift heavy steel plates and safety equipment when repairing pipelines and sewers. Truck-mounted cranes are also used to lift equipment such as pumps and motors during maintenance activities. The current crane unit was purchased in 1993 and has accumulated over 8,110 operating hours, equivalent to approximately 486,600 miles of use. Replacement is required due to equipment age, condition, and increased frequency of maintenance.

Bid Process:

Staff solicited proposals from four distributors of truck-mounted cranes that are members of the Sourcewell Cooperative Purchasing Agreement. Staff received proposals from three distributors, with Altec Industries, Inc. submitting the lowest conforming bid with a total price of \$414,646. Altec's proposal is provided as Exhibit "A".

FISCAL IMPACTS:

Fiscal Year 2022-23 Capital Budget includes sufficient funds to purchase the truck-mount crane.

ENVIRONMENTAL COMPLIANCE:

This item is not a project as defined in the California Environmental Quality Act (CEQA), Code of Regulations, Title 14, Chapter 3, Section 15378.

TRABUCO CANYON WATER DISTRICT WITHDRAWAL FROM SOUTH ORANGE COUNTY WASTEWATER AUTHORITY AND $\underline{\text{CONTINUED SERVICES AGREEMENT}}$

SUMMARY:

Trabuco Canyon Water District (TCWD) proposes to withdraw from participation in the South Orange County Wastewater Authority (SOCWA) Joint Powers Authority (JPA) and to contract with SOCWA for interim recycled water permit services and other long term special services. TCWD is currently only a member of Project Committee (PC) 12, which handles the activity of joint recycled water permit compliance, monitoring, and reporting. TCWD's intent is to obtain and manage its own recycled water permit within 12-18 months. Staff recommends that the Board authorize the General Manager to execute the Consent to the TCWD Withdrawal from SOCWA and Continued Services Agreement, subject to non-substantive changes.

BACKGROUND:

The SOCWA JPA is managed through PCs that represent each major facility or program. Each member agency that has capacity in a facility is a member of the PC for that facility or program. IRWD is currently a member of three PCs responsible for the operation, maintenance, and permitting of Reaches B through E of the Effluent Transmission Main (ETM) and the Aliso Creek Ocean Outfall (ACOO). PC 8 covers the permitting of ocean discharges from several treatment plants, PC 21 covers the ETM Reaches B through E, and PC 24 covers the ACOO. IRWD's assignment of its ETM and ACOO capacity to El Toro Water District and withdrawal from SOCWA will be effective July 1, 2023, after which time IRWD will no longer be a member agency of SOCWA.

TCWD's Proposed Withdrawal from SOCWA:

TCWD is proposing to withdraw from SOCWA and to temporarily contract with SOCWA for recycled water permit services and other long term special services. TCWD is currently only a member of PC 12, which handles the activity of joint recycled water permit compliance, monitoring, and reporting for TCWD, Moulton Niguel Water District, Santa Margarita Water District, and South Coast Water District. TCWD's intent is to obtain and manage its own recycled water permit within 12-18 months. IRWD was previously a member of PC 12 but withdrew in 2018 when IRWD obtained its own recycled water permit, similar to what TCWD is proposing. TCWD is also proposing to contract with SOCWA on a long-term basis for salt and nutrient management plan services and participation in SOCWA's bulk purchasing agreements.

IRWD special counsel has reviewed the agreement and staff recommends approval.

TCWD's involvement within SOCWA is minimal, and their withdrawal will not financially affect IRWD. TCWD's portion of the SOCWA General Fund Budget for future years commencing in July 2023 will be distributed to the remaining SOCWA JPA member agencies. TCWD will pay SOCWA for all contract services and their proportional amount of any Unfunded Pension Obligations (UAL) and Other Post-Employment Benefits (OPEB) allocable to TCWD within 45 days after the effective date of the withdrawal.

SOCWA Withdrawal and Continued Services Agreement (TCWD-SOCWA)

This SOCWA Withdrawal and Continued Services Agreement ("**Agreement**") is dated _______, 2023 ("**Effective Date**") and is between Trabuco Canyon Water District ("**TCWD**"), the South Orange County Wastewater Authority ("**SOCWA**"), and each of SOCWA's other **Member Agencies** as that term is defined below.

- A. <u>Overview</u>. The Joint Exercise of Powers Agreement Creating South Orange County Wastewater Authority ("SOCWA") dated July 1, 2001 (the "Joint Powers Agreement") created a joint powers agency made up of several wastewater service providers within the San Juan Creek and/or Aliso Creek watershed. The nine current members of SOCWA are the City of Laguna Beach, the City of San Clemente, El Toro Water District, Emerald Bay Services District, Irvine Ranch Water District, Moulton Niguel Water District, Santa Margarita Water District, South Coast Water District, and TCWD (collectively, the "Member Agencies"). SOCWA owns and operates wastewater treatment facilities, transmission mains, and outfalls on behalf of its Member Agencies, and facilitates a recycled water reuse permit compliance, monitoring, and reporting program.
- B. <u>TCWD Project Committee Participation.</u> Where a SOCWA activity, project, or facility involves less than all of SOCWA's Member Agencies, the affected Member Agencies form a "**Project Committee**" (or "**PC**") that is responsible for overseeing that activity, project, or facility. TCWD is currently a member of PC 12 (formerly known as PC No. 2SO), which handles the activity of joint recycled water permit compliance, monitoring, and reporting for four of the Member Agencies: TCWD, Moulton Niguel Water District, Santa Margarita Water District, and South Coast Water District. The SOCWA recycled water permit, Order No. 97-52, covers TCWD's Robinson Ranch Water Recycling Plant and related recycled water distribution and use system. TCWD's recycled water program is the smallest of the members, representing approximately 6% of the total SOCWA-permitted service area recycled water by volume.
- C. <u>TCWD Intent to Obtain Independent Recycling Permit.</u> TCWD intends to ultimately obtain and manage its own recycled water permit from state/regional regulators, instead of participating in the joint recycled water permitting services offered by SOCWA¹. TCWD is advised that obtaining an independent permit may take up to 12-18 months.
- D. <u>TCWD Withdrawal from SOCWA.</u> Upon obtaining an independent recycled water permit, TCWD will no longer benefit from most SOCWA activities, projects, or facilities. TCWD currently represents less than 1% of the total revenues and budget of SOCWA². TCWD has determined that, because >99% of the budget of SOCWA is not related to TCWD's operations, that it would be in the best interests of both SOCWA and TCWD for TCWD to withdraw as a member of SOCWA. TCWD will satisfy its actuarial liability arising out of unfunded pension obligations ("UAL") and other post-employment benefits ("OPEB") obligations from its historic participation in PC 12 by making a lump sum payment equivalent to the actuarially-determined liability as provided in this Agreement.

¹ Three other SOCWA Member Agencies have independent recycled water permits: the City of San Clemente, El Toro Water District, and Irvine Ranch Water District. The latter two are former members of PC 12.

- E. <u>Interim Recycled Water Permitting Services</u>. Given the uncertain time frame for TCWD to obtain an independent recycled water permit, and in order to facilitate the orderly transition from joint recycled water permitting under SOCWA to an independent recycled water permit, the parties intend for TCWD to immediately withdraw from SOCWA, and concurrently provide for SOCWA to continue to provide limited other services including participation in bulk purchasing and a salt and nutrient management plan, and in the medium-term to perform recycled water permit services for TCWD under contract instead of under the JPA until TCWD's independent permit is issued. This will avoid the potential for TCWD to have obtained an independent permit while still being a SOCWA member.
- F. <u>Purposes</u>. The Parties intend by this Agreement to provide for (i) TCWD's withdrawal as a member agency from SOCWA; (ii) TCWD's payment of all UAL/OPEB liabilities associated with TCWD's historic membership in SOCWA; (iii) SOCWA's temporary continued provision of recycled water permitting services; and (iv) SOCWA's continued provision of certain other special services on a contract basis.

The Parties therefore agree as follows:

1. JPA Withdrawal.

- 1.1 As of the Effective Date, TCWD is no longer a member of SOCWA and therefore no longer a member of the SOCWA Board of Directors, Project Committee 12, or any other committee. The remaining Member Agencies consent to this withdrawal according to the terms and conditions of this Agreement.
- 1.2 The JPA is hereby amended to remove TCWD as a member of SOCWA or a party to the JPA.
- 1.3 TCWD shall pay to SOCWA all amounts owing to SOCWA that were incurred during its membership in SOCWA within 45 days after receipt of a closing invoice from SOCWA, subject to Section 9 (Liability; Indemnity).
- 2. **Effective Date.** This Agreement will become effective on the last date this Agreement is executed by the SOCWA and the Member Agencies. Regardless of the Effective Date, TCWD shall pay its SOCWA fourth quarter invoice for fiscal year 2022-23.

3. Interim Recycled Water Permitting Services.

- 3.1 <u>Services</u>. Concurrently with TCWD's withdrawal, SOCWA shall provide recycled water permit compliance, monitoring, and reporting services ("**RW Services**") to TCWD pursuant to this Agreement. SOCWA shall perform the RW Services to the same level, to the same extent, and using the same standard of care as those RW Services were provided to TCWD prior to TCWD's withdrawal.
- 3.2 <u>Duration</u>. SOCWA shall provide the RW Services from the Effective Date until TCWD gives 30 days' notice to SOCWA that TCWD no longer requires SOCWA's RW Services.
- 4. **Salt and Nutrient Management Plan Services**. Concurrently with TCWD's withdrawal, SOCWA shall provide services related to development and approval of a Salt and Nutrient Management Plan ("**SNMP**") or other special studies related to production and



distribution of recycled water³ ("**SNMP Services**"). SOCWA shall provide the SNMP Services from the Effective Date until TCWD and SOCWA mutually agree in writing that SOCWA shall no longer provide SNMP Services.

- 5. Costs, Invoicing and Payment. All general references to "Services" in this Agreement include both RW Services and SNMP Services. SOCWA shall invoice TCWD, on no less than a quarterly basis, for all of SOCWA's costs to provide the Services to TCWD. The costs will be allocated to TCWD based on SOCWA's budgeted direct costs, and on a time and materials basis according to the rates set forth in Exhibit 1 (these rates include reasonable overhead and administrative costs). The rates set forth in Exhibit 1 may be reviewed annually and revised to reflect increases in labor or other costs. If SOCWA desires to revise or increase its rates, SOCWA shall deliver with 30 days' notice a proposed revised Exhibit 1; which notice must identify the effective date of the new rates. TCWD will have 30 days from the date notice is delivered to object to the rate increase; if TCWD does not object, the new rates will become effective. If TCWD objects to the proposed new rates, TCWD and SOCWA shall meet and confer to discuss further. The Parties shall negotiate in good faith and TCWD shall not unreasonably refuse to increase time and materials contract service rates. In no event will SOCWA be prevented from increasing its time and material contract service rates by five percent (5%) or less annually. In no event will SOCWA be allowed to increase its time and material contract service rates by more than five percent (5%) without TCWD's consent. TCWD shall pay SOCWA's invoices for all Services under this Agreement by no later than 30 days' after receipt of SOCWA's invoice.
- 6. **UAL/OPEB Liability.** In recognition of TCWD's duty to pay to SOCWA the proportional amount of any UAL/OPEB public retirement system liability allocable to TCWD as of the Effective Date, TCWD shall pay to SOCWA within 45 days after the Effective Date the total amount of \$20,813, as the amount of such liability calculated by SOCWA's actuaries through June 30, 2023 as the anticipated Effective Date, or such amount as re-calculated for a later Effective Date, in full and final settlement of all outstanding UAL/OPEB liability to SOCWA, and upon receipt of that payment, TCWD will be deemed to have satisfied its UAL/OPEB obligations and SOCWA will be deemed to have released and discharged TCWD from any further liability for SOCWA's UAL/OPEB obligations.
- 7. **No JPA Costs.** After the Effective Date, TCWD will not have any responsibility to contribute toward any operational, maintenance, capital, or general fund costs incurred by SOCWA or its Member Agencies, except those costs arising out of or relating to TCWD's prior membership in, or services received from SOCWA, which will be proportional to the services received and identified in the annual use audit as part of the PC 12 costs (and include reasonable overhead and administration costs). If SOCWA does not adopt an annual use audit or budget, then the previous year's annual use audit figures will be used and later reconciled upon adoption of a use audit or budget.
- 8. **SOCWA Bulk Purchases**. TCWD is currently a party to multiple contracts with SOCWA and other Member Agencies for bulk purchasing of services and supplies. SOCWA, until such date as it is terminated or this agreement is modified, shall continue to allow for TCWD to participate in joint purchasing agreements offered to Member Agencies for chemicals, solids hauling, and other services that SOCWA negotiates with third party vendors. TCWD shall

pay to SOCWA its proportional share of the estimated procurement costs for any such contract, based on the formula described in Exhibit 1.

9. Liability; Indemnity.

- 9.1 SOCWA shall indemnify, defend, and hold harmless TCWD from:
- A. any claims, legal, regulatory, enforcement, or administrative actions ("Claims") arising out of or relating to the debts, liabilities, operations, obligations, or facilities owned or operated by SOCWA or any of its Project Committees (except PC 12) that arise on or after the Effective Date, subject to the limitations of the SOCWA Member Agencies Consent contained herein. The parties do not intend to release TCWD from its proportional liability for any Claims relating to TCWD's participation in SOCWA or PC 12 prior to the Effective Date.
- B. Any Claims arising out of or related to SOCWA's Services on or after the Effective Date, except such Claims arising out of any acts or omissions of TCWD.
 - 9.2 TCWD shall indemnify, defend, and hold harmless SOCWA from:
- A. Any Claims that are directly attributable to TCWD's participation in PC 12 prior to the Effective Date.
- B. Any Claims that are the result of TCWD's own acts or omissions that arise on or after the Effective Date.
- C. TCWD's share of any Claims that arise while TCWD is a permittee under the SOCWA recycled use permit and that are shared liabilities deemed the responsibility of all permittees, except those Claims related to SOCWA Services under Section 8.1(B) above.
- 10. **Effect on Prior Rights**. The terms of this Agreement govern the parties and supersede all contrary terms in prior agreements between the parties, including but not limited to the Joint Powers Agreement.

11. Miscellaneous.

- 11.1 Integration, Amendment. This Agreement represents the entire understanding of the parties as to TCWD's withdrawal from SOCWA and concurrent interim contracting for the Services. To the extent that it contradicts or varies from this Agreement, no prior oral or written understanding will be of any force or effect with respect to the matters covered by this Agreement. This Agreement cannot be modified except in a writing approved and executed by all applicable parties.
- 11.2 *Governing Law.* This Agreement is governed by the laws of the State of California and will be construed as if drafted by all parties.
- 11.3 *Third Parties.* This Agreement does not create any third-party beneficiary or any rights in any person or party other than the parties.



- 11.4 Signing Authority. Each Party represents and warrants that each person or persons executing this Agreement on its behalf is duly authorized to do so by the respective Party and that this Agreement binds the parties.
- 11.5 *Notices*. Any written notice required by this Agreement must be made by U.S. mail or by reliable overnight courier and delivered to the following address, together with a courtesy copy by email:

Any party may, by written notice to the others, designate a different address or addressee, which will be substituted immediately for that specified above.

- 11.6 Severability. If any provision of this Agreement, for any reason, is held to be invalid, illegal, or unenforceable in any respect, that invalidity, illegality, or unenforceability will not affect any other provision of this Agreement, but this Agreement will be construed as if the invalid, illegal, or unenforceable provision had never been set forth, and the remainder will be enforceable to the fullest extent permitted by law to effectuate the original intent of the Parties.
- 11.7 Successors & Assigns. The terms of this Agreement are binding upon and will inure to the benefit of and be enforceable by the respective successors and assigns of the parties.
- 11.8 *Counterparts.* This Agreement may be executed in counterparts, each of which is an original, but all of which together will constitute one and the same instrument.

The parties are signing this Agreement as of the Effective Date.

2023 RECHARGE PROGRAM WITH BUENA VISTA WATER STORAGE DISTRICT

SUMMARY:

It is expected that current wet-year conditions will result in Kern River water supplies being available for recharge at the IRWD Water Bank for an extended period of time. In 2011, 2017, and 2019, the IRWD Board approved one-year recharge programs that allowed Buena Vista Water Storage District (BVWSD) to augment the recharge of high-flow Kern River water under the existing long-term exchange program between IRWD and BVWSD. To maximize IRWD's opportunity to secure additional water supplies through 2023, staff recommends that the Board authorize the General Manager to execute a letter agreement with BVWSD based on the terms presented giving IRWD the ability to allow BVWSD to augment high-flow Kern River supplies delivered into storage at the IRWD Water Bank.

BACKGROUND:

In 2010, IRWD and BVWSD entered into a long-term *Agreement for Water Acquisition by Irvine Ranch Water District from Buena Vista Water Management Program* (Exchange Agreement), which established an exchange program at the Strand Ranch portion of IRWD's Water Bank. The Exchange Agreement allows BVWSD to recharge up to 17,500 acre-feet (AF) of high-flow Kern River water per year at the Strand Ranch on an unbalanced exchange basis, with IRWD receiving 50% of the water, less a proportional share of losses. BVWSD's allocated annual rate of recovery under the Exchange Agreement is 6,667 AF.

2011 Recharge Program:

After purchasing the Stockdale West property in December 2010, IRWD constructed recharge basins on the Stockdale West portion of the IRWD Water Bank. In August 2011, IRWD and BVWSD entered into an agreement allowing BVWSD to use the Stockdale West recharge basins for one year to capture up to 10,000 AF of high-flow Kern River water on an unbalanced exchange basis. BVWSD recharged 3,268 AF of high-flow Kern River water using the Stockdale West basins, in addition to 17,500 AF at the Strand Ranch.

2017 Recharge Program:

In 2017, IRWD executed an agreement with BVWSD for a one-year recharge program to augment recharge using the Stockdale West recharge facilities for up to an additional 12,500 AF. Based on a request from BVWSD, the IRWD Board approved several modifications from the terms of the Exchange Agreement, which only applied to water recharged in 2017. These changes included providing BVWSD with an additional 833 AF per year of first priority recovery capacity to use in recovering water that was recharged in 2017. BVWSD was also allowed additional time to request return deliveries before having to transfer additional water to

IRWD. All other terms for the one-year recharge program were consistent with the Exchange Agreement. In 2017, BVWSD recharged 13,654 AF utilizing the Strand and Stockdale West recharge basins with IRWD receiving 6,827 AF.

2019 Recharge Program:

In 2019, IRWD executed an agreement with BVWSD for a one-year recharge program to augment recharge under the Exchange Agreement utilizing the Stockdale West recharge facilities for up to an additional 12,500 AF. As that water year progressed, it became less likely that BVWSD would have excess supplies to deliver to IRWD's Water Bank. The IRWD Board then authorized staff to purchase water from BVWSD. In 2019, IRWD purchased 5,974 AF from BVWSD at \$110 per AF. The BVWSD water was recharged on an unbalanced exchange basis consistent with the Exchange Agreement, with IRWD paying BVWSD for only IRWD's share of the water delivered into storage.

Proposed 2023 Recharge Program:

As a result of current wet year conditions, it is expected that increased outflows from Lake Isabella will create high-flow conditions on the Kern River for an extended period of time. BVWSD has expressed interest in augmenting its Exchange Agreement recharge capacity while receiving compensation from IRWD. Staff has evaluated BVWSD's request and prepared mutually beneficial terms for a 2023 Recharge Program that maximizes the use of IRWD's recharge facilities and equalizes costs for IRWD and BVWSD. Implementation of the proposed 2023 Recharge Program would at IRWD's discretion provide the following:

- After first delivering 17,500 AF under the Exchange Agreement, BVWSD could deliver a minimum of 4,500 AF of high-flow Kern River on a second priority basis;
- If BVWSD augments recharge by at least 4,500 AF, then IRWD would pay BVWSD \$25 per AF for its share of water delivered under the Exchange Agreement and the 2023 Recharge Program;
- BVWSD would pay all actual recovery costs for its share of water delivered under the 2023 Recharge Program, estimated at \$120 per AF;
- If BVWSD augments recharge by at least 4,500 AF, then BVWSD would be provided additional annual recovery capacity of 750 AF on a first priority basis;
- All other terms and conditions under the Exchange Agreement would apply to the proposed Recharge Program.

The draft Term Sheet for the proposed 2023 Recharge Program with BVWSD is attached as Exhibit "A". To maximize IRWD's opportunity to secure wet-year water supplies throughout 2023, staff recommends that the Board authorize the General Manager to execute a letter agreement with BVWSD based on the terms presented, giving IRWD the ability to allow BVWSD to augment high-flow Kern River supplies delivered into storage at the IRWD Water Bank.

FISCAL IMPACTS:

If BVWSD delivers at least 22,000 AF of water to the IRWD Water Bank in 2023, IRWD would pay BVWSD \$25 per AF of IRWD's share of the water delivered. BVWSD would pay all actual recovery costs for its share of the water delivered under the 2023 Recharge Program at a rate of approximately \$120 per AF. IRWD's total cost of the water delivered under the Exchange Agreement is estimated to range from \$115 to \$130 per AF, depending upon recovery costs.

Pursuant to the Exchange Agreement, if after year four BVWSD has not recovered its water, IRWD would compensate BVWSD for additional water transferred from BVWSD to IRWD in excess of 50% at BVWSD's then current State Water Project Table A Variable Operations, Maintenance, Power and Replacement unit cost rate for water. The current estimated cost of additional water is approximately \$27 per AF.

ENVIRONMENTAL COMPLIANCE:

In compliance with the California Environmental Quality Act (CEQA), the California Public Resources Code Section 21000 et. seq., and per the California CEQA Guidelines in the Code of Regulations, Title 14, Division 6, Chapter 3, Rosedale as lead agency filed a Notice of Determination for the Stockdale Integrated Banking Project Final Environmental Impact Report (EIR) with the County of Kern on December 8, 2015, and with the State Clearinghouse on December 9, 2015. IRWD, as a responsible agency, filed a Notice of Determination with the County of Orange on December 14, 2015, with the California State Clearinghouse on December 15, 2015, and with the County of Kern on December 21, 2015. The banking of BVWSD high flow Kern River water available from BVWSD pre-1914 water rights is consistent with the sources evaluated in the Stockdale Final EIR as well as the Final EIR for the Strand Ranch Integrated Banking Project. A Final EIR for the Buena Vista Water Management Project was prepared, certified and the project approved by BVWSD. The Buena Vista Water Management Project Final EIR covers the delivery of BVWSD high flow Kern River water to water banking facilities such as the Strand and Stockdale Integrated Banking Projects and includes Rosedale facilities.

COMMITTEE STATUS:

Based on timing and urgent necessity, this item was not reviewed with the Supply Reliability Programs Committee.

RECOMMENDATION:

THAT THE BOARD AUTHORIZE THE GENERAL MANAGER TO EXECUTE A LETTER AGREEMENT WITH BUENA VISTA WATER STORAGE DISTRICT FOR A 2023 RECHARGE PROGRAM BASED ON TERMS PRESENTED, SUBJECT TO NON-SUBSTANTIVE CHANGES, GIVING IRWD THE ABILITY TO ALLOW BUENA VISTA WATER STORAGE DISTRICT TO AUGMENT THE SUPPLIES DELIVERED INTO STORAGE AT THE IRWD WATER BANK.

Terms for a 2023 Recharge Program to Augment Recharge under the Agreement between Irvine Ranch Water District and Buena Vista Water Storage District

GENERAL TERMS

Entities: Irvine Ranch Water District ("IRWD"); Buena Vista Water Storage

District ("BV")

Description: IRWD and BV seek to implement a 2023 Recharge Program to augment

the recharge capacities under the IRWD Water Exchange Program established in the long-term Agreement for Water Acquisition by IRWD from BV Water Management Program that was executed on December 22,

2010 ("IRWD/BV Exchange Agreement"). Recharge would be

augmented through the delivery of BV Exchange Water to IRWD's other recharge facilities and capacities on a 2-for-1 basis consistent with the IRWD/BV Exchange Agreement as described in this term sheet ("Term Sheet"). Capitalized terms used herein and not otherwise defined shall have the same meanings as are given to such terms in the IRWD/BV

Exchange Agreement.

Effective Date: Upon execution by the Parties (the "Effective Date").

Term: Terminating on December 31, 2023.

Recharge Project(s): IRWD has constructed recharge facilities at its Stockdale West property in

Kern County, California. These facilities consist of approximately

259 acres of recharge basins and appurtenant facilities to convey water to the Stockdale West property from the Strand Ranch Integrated Banking Project and a turnout from the Cross Valley Canal. IRWD may use recharge and recovery capacities developed on the Stockdale West

property for the 2023 Recharge Program.

Exchange Program: The IRWD/BV Exchange Agreement provides for storage of BV

Exchange Water on a 2-for-1 basis consistent with the BV Water Management Program, which includes a Water Exchange Program that allows BV to more effectively and beneficially manage BV's water resources. The IRWD/BV Exchange Agreement allows BV to supply up to 17,500 acre-feet (AF) of BV Exchange Water in any given year for recharge at the Strand Ranch Integrated Banking Project and provides for IRWD to return fifty percent (50%) of the water less losses at a rate of no more than 6,667 AF in any given year. As consideration, the remainder of the water is deemed transferred to IRWD with provisions for additional transfers that are dependent on time length of storage. The IRWD/BV Exchange Agreement has a term through January 13, 2039, extendable by

the Parties.

Non-Binding Effect: This Term Sheet is intended to be a statement of the terms of the proposed

transaction. It is subject to the execution of a letter agreement ("Letter Agreement") by IRWD and BV inclusive of the terms and conditions set

forth herein.

General Expenses: Each party shall be responsible for its own fees and expenses arising out

of the negotiation and execution of agreements related to this transaction,

obtaining necessary approvals, and the like.

CEQA Compliance: Both parties shall comply with CEQA and cooperate with one another

with respect to CEQA compliance for the proposed Recharge Program. BV was the lead agency with respect to CEQA compliance for its BV Water Management Program, which included the Water Exchange Program, and adopted a Final Environmental Impact Report (EIR) on January 12, 2010. IRWD was a responsible agency with respect to CEQA compliance for the Stockdale Integrated Banking Project, including the delivery of BV Exchange Water to the Stockdale West, and adopted a Final EIR on December 14, 2015. IRWD was a responsible agency with respect to CEQA compliance for the Strand Ranch Integrated Banking Project and adopted a Final EIR on May 27, 2008. BV and IRWD shall each be responsible for its own fees and costs associated with future or additional CEQA compliance regarding its participation in the Recharge

Program, including litigation expenses if any.

Permit Costs: As provided in the IRWD/BV Exchange Agreement (Section 1(F)),

however, no permit costs are expected for the Recharge Program.

Water Rights: As provided in the IRWD/BV Exchange Agreement (Section 1(G);

Section 3(B) (ii) (4)).

RECHARGE PROGRAM TERMS

Source of Water: As provided in the IRWD/BV Exchange Agreement (Section 2(A)(i)).

Water Quantity: At IRWD's discretion and on a second priority basis to IRWD's other

exchange programs, BV may deliver a minimum of 4,500 additional acre-feet (AF) of water (subject to recharge rates at the time of deliveries) during the term hereof (referred to as "Augmentation Water"), to augment the 17,500 AF of BV Exchange Water that BV is allowed to supply to the Strand Ranch Integrated Banking Project, as specified in the IRWD/BV Exchange Agreement, resulting in at least a total of 22,000 AF of BV water to be repharged during the 2023 Backerge Program. The

water to be recharged during the 2023 Recharge Program. The

Augmentation Water is to be stored in an account within the Stockdale Integrated Banking Project within the estimated storage capacity of 26,000. The use of this storage capacity in the Stockdale Integrated

Banking Project will not increase the dedicated storage capacity amount as

specified in the IRWD/BV Exchange Agreement.

The 2023 Recharge Program shall augment or increase the existing annual recovery capacity of 6,667 AF as provided in the IRWD/BV Exchange Agreement for delivery of IRWD Return Water to BV by an annual amount of 750 AF. The 750 AF would be provided on a first priority basis subject to BV delivering at least 4,500 AF of Augmentation Water. The resulting 7,417 AF augmented recovery capacity will be used to make IRWD Return Water deliveries to BV associated with this 2023 Recharge Program and IRWD Water Exchange Program and shall not augment or increase future IRWD Return Water deliveries not associated with this 2023 Recharge Program.

Water Quality: As provided in the IRWD/BV Exchange Agreement (Section 2(A)(iii)).

Availability: As provided in the IRWD/BV Exchange Agreement (Section 2(A)(IV)).

Delivery Points: As provided in the IRWD/BV Exchange Agreement (Section 2(A) (v)).

Notwithstanding that recharge of the Augmentation Water will occur on the Stockdale West property, the location of storage, recovery, return and delivery points shall be the same as for water other than Augmentation

Water.

Consideration: At IRWD's discretion, BV may deliver a minimum of 4,500 AF of

Augmentation Water in addition to the 17,500 AF of Exchange Water delivered under the IRWD/BV Exchange Agreement. If at least 4,500 AF of Augmentation Water is delivered, IRWD agrees to pay BV \$25.00 per AF for IRWD's share of the Augmentation Water and Exchange Water delivered by BV during the term of this 2023 Recharge Program. BV agrees to pay all costs associated with recovering and delivering its share of the Augmentation Water to the BV POD as defined in Section 2(A)(v)

of the IRWD/BV Exchange Agreement.

Other Terms: Except where otherwise specified above or the context requires otherwise,

all terms and conditions of the IRWD/BV Exchange Agreement are incorporated and will apply to this Term Sheet, the Letter Agreement and disposition of the Augmentation Water including without limitation the return of water to BV, construction of facilities, indemnifications and duties related to the operation, maintenance, power and repairs. For the purpose of this Term Sheet and the Letter Agreement, such terms and conditions of the IRWD/BV Exchange Agreement shall be read and construed as though references therein to the Agreement or the words "herein," "hereof," and the like were to this Term Sheet and the Letter Agreement, and references to water included the Augmentation Water.
