Plaintiff and Petitioner Irvine Ranch Water District ("IRWD"), a California public agency, seeks a judgment invalidating the Orange County Water District's ("OCWD") Resolution No. 16-4-37.

26 DETAILED SUMMARY OF THE MATTER PLAINTIFF AND PETITIONER SEEKS TO INVALIDATE:

IRWD brings this reverse validation action to challenge OCWD's adoption of its Resolution
No. 16-4-37, which established the Basin Production Percentage and the Basin Equity
Assessments for fiscal year 2016-2017. Resolution No. 16-4-37 was adopted at a regular

meeting of the OCWD Board of Directors on April 20, 2016. The Basin Equity Assessment is a monetary assessment levied on groundwater produced from the Orange County Groundwater Basin ("Basin") in excess of the Basin Production Percentage, a groundwater 1 2 production limit set by OCWD. In adopting Resolution No. 16-4-37, OCWD improperly excludes recycled water from consideration as a "Supplemental Source" of water in calculating the Basin Production Percentage and IRWD's "total water demand," and by doing so, violates 3 the terms of the OCWD Act (Water Code-Appendix, Chap. 40). Section 31.5 of the OCWD Act defines Supplemental Sources broadly to include all sources of water outside the watershed, including recycled water, and is not limited to imported water from the Metropolitan Water District of Southern California. Therefore, OCWD's actions have 4 5 arbitrarily created a penalty on the use of recycled water, which is contrary to state policy and 6 financially detrimental to IRWD's customers. Additionally, OCWD has adopted an improper practice of prohibiting the "unlawful exportation" of groundwater outside the OCWD district, which OCWD lacks the statutory authority to impose under the OCWD Act. Aside from 7 lacking the authority to do so under law, the methodology OCWD uses to determine when an 8 "unlawful export" occurs is flawed and also fails to allow recycled water to be considered part of total water use. The inability to properly account for recycled water as part of IRWD's total 9 water use threatens to curtail pumping of groundwater to which IRWD has a vested right and interferes with IRWD's ability to plan for the future needs of IRWD customers. 10 You may contest the legality or validity of the above matter by appearing and filing a 11 written pleading in response to the complaint on or before August 1, 2016. Otherwise, upon application of the plaintiff and petitioner, the court may enter judgment for the 12 relief requested in the complaint, to wit, the declaration that Resolution No. 16-4-37 may be voided, invalidated, and set aside by Court order.
