

#### 2020 LEGISLATIVE AND REGULATORY UPDATE

#### **SUMMARY:**

This report provides an update on the 2019-2020 legislative session, regulatory issues, and IRWD priorities. As legislation and regulations develop, staff will provide updates and recommendations to the Water Resources Policy and Communications Committee and the Board, as appropriate.

#### BACKGROUND:

Following a nearly two-month recess due to COVID-19, the Assembly returned and resumed legislative activity on May 4. The State Senate returned and resumed legislative activity on May 11. One of the consequences due to the difference in return dates between the two houses is that the legislative calendars for each house do not synchronize until July 13, 2020. This means that the first policy and fiscal committee deadlines are different for the Assembly and Senate.

In the Assembly, May 22 was the last day for policy committees to hear and report fiscal bills while May 29 was the last day for policy committees to hear non-fiscal bills. June 5 is the fiscal committee deadline in the Assembly, and the Assembly's house of origin deadline is June 19 this year, which is the day the Assembly will begin its summer recess. The Assemblymembers will return from summer recess on July 13.

In the Senate, May 29 was the last day for policy committees to hear and report fiscal bills while June 5 was the last day for policy committees to hear non-fiscal bills. June 19 is the fiscal committee deadline in the Senate, and the Senate's house of origin deadline is June 26. The Senate will begin its summer recess on July 2 and will return on July 13.

A copy of the 2020 Legislative Matrix is provided as Exhibit "A". Links to the bills discussed below are included within each discussion, unless a separate exhibit is noted.

#### State Budget Update:

#### Governor's May Revise:

Governor Newsom released the May revision to his proposed Fiscal Year 2020-21 Budget (the May Revise) on May 14, 2020. For FY 2020-21, the May Revise proposes \$133.9 billion in total General Fund expenditures, projects \$129.6 billion in total General Fund revenues, and proposes to draw down the Budget Stabilization Account/Rainy Day Fund to \$8.3 billion, which is a \$7.8 billion decrease. Another \$450 million is proposed to be used from the Safety Net Reserve. This compares to the \$153.1 billion in total General Fund expenditures, \$151.6 billion in projected General Fund revenues, and \$1.9 billion proposed to be added to the Budget

Stabilization Account/Rainy Day Fund, which was included in the Governor's Proposed Budget in January. The addition of the \$1.9 billion would have brought the forecasted total of Budget Stabilization Account/Rainy Day Fund to \$17.9. When compared to the enacted Fiscal Year 2019-2020 budget, the May Revise represents a \$12.6 billion, or 8.6 percent, decrease in General Fund expenditures.

According to the Governor's May Revise, "[t]he COVID-19 pandemic and resulting recess has changed the fiscal landscape dramatically... Compared to the January forecast, General Fund revenues are projected to decline over \$41 billion. This revenue drop, combined with increased costs in health and human services programs and the added costs to address COVID-19, leads to a projected budget deficit of approximately \$54 billion before the changes proposed in the May Revision." (May Revise – 2020-21 Introduction, Page 2-3)

The May Revise proposes to close the \$54 billion budget deficit through the following:

Of note with the May Revise and the fiscal challenges facing the State, the Administration announced that the Governor no long supports the idea of a Climate Resilience Bond on the November 2020 ballot. Despite this, some members of the Legislature continue to pursue a bond, now referring to it as an economic stimulus bond.

The Legislature has until June 15 to pass a balance budget, and until June 25 to place a bond on the November ballot. Staff will provide the Committee with an update on the latest budget discussions.

#### 2020 State Legislative Update:

Legislation Related to De-energization Events:

To reduce the risk of catastrophic wildlife, electric utilities have begun to institute Public Safety Power Shutoffs (PSPS). A PSPS event is a de-energization event in which the power in high-risk areas is turned off to reduce the likelihood of a wildfire starting from downed power lines and related equipment. IRWD, like many other water and sewer providers, has been affected by PSPS events.

To prepare for a loss of electricity, IRWD has set up generators at all of its critical facilities to ensure that IRWD has the power to keep water and sewer systems operating. While IRWD is prepared to continue operating during these PSPS and other de-energization events, the District's backup generators are regulated by various air quality regulations which place limits on the runtimes of backup generators and the testing that can be performed on them.

There is one bill that would be beneficial to IRWD with regard to PSPS events, <u>SB 1099 (Dodd, D-Santa Rosa)</u>. SB 1099, as currently drafted, would require air districts to adopt a rule to allow critical facilities with a permitted emergency backup generator to use that generator during a denergization event of other loss of power.

California Municipal Utilities Association and Las Virgenes Municipal Water District have been working on amendments to the bill in order to move it forward this year. The bill will be amended as it moves through the Senate Energy, Utilities and Communications Committee. The amendments, which are included as Exhibit "B", would require the South Coast Air Quality Management District to develop stipulations for an order of abatement that allows an operator of a critical facility to use its backup generators in exceedance of the permitted runtimes during a PSPS event provided the operator agrees to replace the backup generators with the cleanest feasible and applicable technology over a period of time.

IRWD currently has a "support" position on SB 1099. Staff will provide the Committee with an update on this legislation.

Legislation Related to Fees on Residential Housing Development:

One of the prominent topics of discussion during the 2019 legislative year was the lack of affordable housing in California. At the end of the legislative year, the discussion on housing affordability turned to the fees assessed on new housing development. At that time, Assemblymember Timothy Grayson (D-Concord) amended AB 1484 to proposes a number of changes to the laws governing fees charged to new housing developments, including connection fees. Staff engaged with IRWD's associations and industry partners to seek the removal of connections fees from the scope of AB 1484; however, the legislative year ended before Assemblymember Grayson could work on AB 1484 further.

On February 24, 2020, Assemblymember Grayson, in conjunction with Assemblymembers David Chiu (D-San Francisco), Rob Bonta (D-Oakland), Todd Gloria (D-San Diego), and Jesse Gabriel (D-San Fernando Valley), held a press conference announcing a package of eight bills meant to address development fees on housing developments. Those eight bills are no longer moving forward this year; however, Assemblymember Grayson has indicated that he plans to seek enactment of AB 1484 this year.

Staff will discuss AB 1484 with the Committee, and current efforts to seek amendments to the bill. AB 1484 is currently in the Senate Rules Committee, which was referred to Committee after being amended on the Senate Floor last year.

#### Additional 2020 State Legislation of Interest to IRWD:

There are many other bills of interest to the District, including:

- AB 828 (Ting) Temporary Moratorium on Foreclosures and Unlawful Detainer Actions: Among other things, AB 828 would prohibit an eviction of a residential tenant during the COVID-19 state emergency and through 15 days after the emergency ends. It would also require a court to permit a residential tenant, who has not paid their rent, to remain in the property if they pay their monthly rent plus 10 percent of the unpaid rent owed each month. AB 828 is currently in the Senate Rules Committee;
- <u>AB 2406 (Wicks) Rental Registry Online Portal:</u> AB 2406 would require the Department of Housing and Community Development (HCD) to create an online rental registry portal. It would require landlords who own and operate five or more rental dwelling units and accept rental assistance payments from federal or state funds that are provided in response to the COVID-19 emergency, to submit information to HCD's portal. It also prohibits a landlord taking certain actions until the information is submitted. AB 2406 is currently in the Assembly Appropriations Committee;
- <u>SB 939 (Wiener) COVID-19 Commercial Tenancy Evictions:</u> SB 939 would prohibit a landlord from evicting tenants of a commercial property during the COVID-19 state emergency. It would also authorize a commercial tenant that is a small business experiencing a decline of 40 percent or more in monthly revenue as compared to two months before the shelter-in-place order took effect or to the same month in 2019, and commercial tenants that are eating or drinking establishments, places of entertainment, or performance venues suffering a decline of 25 percent or more in capacity due to social distancing orders or safety concerns, to renegotiate their lease. It would permit the commercial tenant to terminate its lease if the landlord and tenant are not able to reach agreement on lease modifications within 30 days of receiving a notice from the tenant that he wants to renegotiate his lease. SB 939 is currently in the Senate Appropriations Committee; and
- SB 1410 (Gonzalez) COVID-19 Emergency Rental Assistance Program: SB 1410 would establish the COVID-19 Emergency Rental Assistance Program. The program would develop a program to assist households who have been unable to pay their rent due to COVID-19 with paying all or a part of their rent due between April 1, 2020, and December 31, 2020. It would also prohibit a landlord who receives rent payment from a program from raising their gross rental rate and seeking an eviction due to unpaid rents. SB 1410 is currently in the Senate Appropriations Committee.

Because the bill has the potential to impact IRWD's investment and real property transactions, staff is tracking and monitoring these bills closely. Staff will discuss these bills with the Committee.

Staff will also discuss the following bills with the Committee:

- AB 1672 (Bloom) Nonwoven Disposable Products, and
- SB 1386 (Moorlach) Local Government- Water Assessments, Fees and Charges. (co-sponsored by Irvine Ranch Water District and San Diego County Water Authority).

#### 2020 State Regulatory Update:

The following is a list of some of the State regulations and agency reports staff is monitoring, tracking or planning to engage in over the next three to 12 months. As the next drafts of the regulations or report are released for public review and comment, staff will engage, as appropriate. Staff will also provide an oral update to the Committee on any new developments related to these regulations.

The pending regulations and reports actively being tracked include the:

- California Plumbing Code Update;
- Department of Water Resources (DWR) and the State Board's implementation of the "Making Water Conservation a California Way of Life" legislation;
- State Board's Chromium-6 Drinking Water Economic Feasibility Analysis;
- State Board's development of a "Cross Connection Policy Handbook;"
- State Board's proposed "Environmental Laboratory Accreditation Program Regulations:"
- State Board's proposed "Mercury TMDL and Statewide Mercury Control Program for Reservoirs" regulations;
- State Board's proposed definition of "Microplastics in Drinking Water";
- State Board's Safe and Affordable Drinking Water Fund Implementation and Safe and Affordable Funding for Equity and Resilience (SAFER) Program;
- State Board's "Water Loss Performance Standards Regulations;"
- State Board's Water Rights Enforcement Policy; and
- State Board's "Water Quality Control Plan for Inland Surface Waters, Enclosed Bays, and Estuaries of California" and draft "Toxicity Provisions."

#### 2020 Federal Legislative Update:

IRWD's federal advocacy efforts in 2020 continue to largely focus on seeking federal funding for the Kern Fan Groundwater Storage Project and advocating for an increased funding authorization for the federal Water Storage Program. As the nation's attention has shifted to COVID-19, staff and the District's advocates have been tracking the federal legislation dealing with the coronavirus. Staff will update the Committee on these efforts and will update the Committee on the ongoing efforts related to positioning the Kern Fan Groundwater Storage Project for federal funding this year.

#### THE PEOPLE OF THE STATE OF CALIFORNIA DO ENACT AS FOLLOWS:

#### **SECTION 1.** The Legislature finds and declares all of the following:

- (a) Catastrophic wildfires and other natural disasters are increasing in frequency and intensity due to climate change and other factors.
- (b) Wildfires dramatically increase carbon emissions and work against the state's goals to reduce greenhouse gas emissions and achieve a carbon-neutral future.
- (c) Wildfires and other natural disasters also can cause significant impacts and a threat to the state's water and wastewater facilities, which are critical to ensuring a safe and reliable water supply for people, businesses, agriculture, and the environment.
- (d) To help mitigate the risks of wildfires, investor-owned utilities have initiated public safety power shutoffs to deenergize parts of their distribution systems, and, in some cases, portions of the transmission system, actions that reduce or eliminate access to a reliable power supply for the state's water agencies as they count on a reliable source of electricity to move and deliver water.
- (e) Actions need to be taken to reduce the impacts of deenergization wildfires, and other events on critical facilities, including increasing access to alternative power sources that can help support a safe and reliable water supply and maintain the state's ability to effectively respond to wildfires.
- **SEC. 2.** Article 9.5 (commencing with Section 42010) is added to Chapter 3 of Part 4 of Division 26 of the Health and Safety Code, to read:

#### Article 9.5. Emergency Backup Generators

#### **42010.** For purposes of this article, the following terms apply:

(a) "Critical facility" means a facility necessary or convenient in providing essential public services, including, but not limited to, facilities such as hospitals, police stations, fire stations,

emergency operations centers, water and wastewater facilities, incident command posts, and communication systems used to support essential public services.

- (b) "Deenergization event" means the interruption of power due to a public safety power shutoff.
- (c) "Emergency backup generator" means an internal combustion engine greater than 50 brake horsepower and gas turbines greater than 2,975,000 British thermal units per hour for nonutility power generation that does not operate more than 200 hours per year and is only operated in the event of an emergency power failure or for routine testing and maintenance.
- (d) "Loss of power" means a failure in an electric generation, distribution, and transmission system or a disruption to electrical power from an electricity provider due to an emergency event, including a wildfire.
- (e) "Public safety power shutoff" means a preventative measure to deenergize all, or a portion of, an electric generation, distribution, or transmission system when the electricity provider reasonably believes there is an imminent and significant risk that strong winds, or other extreme and potentially dangerous weather events, increase the probability of a wildfire.
- (f) "Water and wastewater facilities" includes drinking water and wastewater treatment plants, pumping stations, storage facilities, and water facilities needed to maintain water service and the water pressure necessary for firefighting.

#### 42451 is amended to read:

- (a) On its own motion, or upon the motion of the district board or the air pollution control officer, the hearing board may, after notice and a hearing, issue an order for abatement whenever it finds that any person is constructing or operating any article, machine, equipment, or other contrivance without a permit required by this part, or is in violation of Section 41700 or 41701 or of any order, rule, or regulation prohibiting or limiting the discharge of air contaminants into the air.
- (b) As an alternative to subdivision (a), the hearing board may issue an order for abatement pursuant to the stipulation of the air pollution control officer and the person or persons accused of constructing or operating any article, machine, equipment, or other contrivance without a permit required by this part, or of violating Section 41700 or 41701, or any order, rule, or regulation prohibiting or limiting the discharge of air contaminants into the air, upon the terms and conditions set forth in the stipulation, without making the finding required under subdivision (a). The hearing board shall, however, include a written explanation of its action in the order for abatement.

(c)(1) Pursuant to subdivision (b), an air pollution control officer shall (either within 12 months of this paragraph becoming operative or, if the air district does not currently have rules limiting backup generator hours during an emergency, 12 months after the adoption of such rules) develop stipulations for an order of abatement that allows the operator of a critical facility to use emergency backup generators in exceedance of runtime and/or testing and maintenance limits under the following conditions:

(A) If the operation occurs as the result of a deenergization event or other loss of power

- (B) If the testing and maintenance is in accordance with National Fire Protection Association (NFPA) 110 Standard for Emergency and Standby Power Systems.
- (2) In accordance with the stipulated order, the operator of a critical facility shall be subject to certain conditions negotiated with the air district including, but not limited to:
- (A) a schedule for replacing their Tier 1 or lower emergency backup generators with the cleanest feasible and applicable technology.
- (B)The replacement schedule shall be technically and economically feasible and consider the useful life of the generator.
- (C) reporting requirements after a deenergization event or testing and maintenance that results in an exceedance of an operational limit.
- (3) The stipulated order shall not be in effect for more than five years or the length of time agreed upon for generator replacement.
- (4) The stipulated order is subject to hearing board approval.
- 42012. (a) Consistent with federal law, a district shall adopt a rule, or revise its existing rules, to allow critical facilities with a permitted emergency backup generator to do any of the following with that emergency backup generator without having it count toward that permitted emergency backup generator's time limitation on actual usage and routine testing and maintenance:
- (1) Use the emergency backup generator during a deenergization event or other loss of power.
- (2) Test or maintain the emergency backup generator for consistency with any of the following:
- (A) The National Fire Protection Association Standard 110 for Emergency and Standby Power Systems, or its successor.
- (B) Industry best practices
- (C) Recommendations by the manufacturer of the emergency backup generator.
- (b) A district shall not impose a fee on the issuance or renewal of a permit issued for an emergency backup generator described in subdivision (a).
- **SEC. 3.** If the Commission on State Mandates determines that this act contains costs mandated by the state, reimbursement to local agencies and school districts for those costs shall be made pursuant to Part 7 (commencing with Section 17500) of Division 4 of Title 2 of the Government Code.
