



# IRWD Meter Application Requirements

## Dual Plumbed Custom Lot

### Temporary Construction Meters

Connection, deposit, and applicable domestic meter fees must be paid by check with the Residential/Non-Residential Meter Application to IRWD prior to starting construction.

All items listed below must be presented when applying for water meter(s). Our office cannot accept information submitted separately or by email. If information is missing, application will not be accepted.

Please allow 2-3 weeks from the time information is received, complete and correct, to process the application. An email will be sent to you with a copy of the completed Temporary Construction application and activation number required for activation.

If a hydrant meter is necessary to begin construction prior to the processing of the in-ground temporary construction meter, please see Temporary Construction Hydrant Meter Request Requirements.

**To activate a meter**, please leave a voicemail on the meter activation line at 949-453-5426 and your previously submitted and processed applications will be routed.

#### 1 Temporary Construction Meter Application (domestic service)

Application will be filled out with the developer or contractor information. The temporary construction meter account will be set up and billed to this name. This account cannot be billed to the homeowner. IRWD will print and provide a copy of the approved civil plans to accompany the application.

#### 2 Location Details

Provide the tract number, lot number, and address so that IRWD may pull the civil plans.

#### 3 Deposit, Connection Fee, Meter Fee

There will be a **\$1,000 deposit** required from the developer or contractor for the temporary construction meter. The company on the check will be billed for the consumption and monthly service charges. This deposit amount will be applied against the final bill once construction is complete; if any of the deposit remains, a refund will be issued.

Current connection fee(s) must be paid by the homeowner on a separate check from the deposit.

Please note that 1-1/2" domestic meters to the home are pre-paid. If the customer requires a larger meter, the difference in cost would need to be paid along with the above mentioned items.

Six to eight weeks from construction completion, the homeowner must submit applications for the permanent domestic and recycled meters. See reverse for requirements.

### Permanent Residential & Irrigation Meters

Processing of the permanent residential meter application is the only way to close out the account for the temporary construction meter.

All items listed below must be presented when applying for the water meters. Applications for the domestic to the home and recycled to the irrigation must be submitted simultaneously.

Please allow 2-3 weeks from the time information is received, complete and correct, to process the application. An email will be sent to you with a copy of the completed Permanent Residential and Irrigation meter applications. This application will automatically be activated and provided to the inspector.

#### 1 Permanent Residential Meter Application and Recycled Irrigation Meter Application

Separate applications are required for each of the domestic and recycled meters and are to be filled out with the homeowner information. Both accounts will be set up and billed to this name.

#### 2 Approved Civil Plans

IRWD will provide a copy of the approved civil plans to accompany both applications. These are the same plans provided with the Temporary Construction meter. Tract and lot number must be provided to IRWD.

#### 3 Approved Landscape Plans

Plans are to be provided in 11" x 17", must show approval signature of IRWD On-Site Inspector, and highlight meter location.

#### 4 City Approved Address Document for Unique Address

All meters must have a unique address even if all meters are serving the same location. Addresses with fractions will not be accepted; acceptable variations of the address may include decimals up to two places (e.g. 123.25 Main St.)

#### 5 Meter Fee Payment

1-1/2" domestic meters to the home are pre-paid. Any upsizing will require payment of the difference from the current 1-1/2" size to the desired size.

Payment of the irrigation meter is required at the time of application according to the size of the meter.

#### 6 OCFA Approval Documents

5/8 x 3/4" Disc and 3/4" Disc meters may require approval documents from OCFA or governing fire agency.

10" Turbo	6 – 5,500	Verify cost & availability

*Recycled water (where available) is to be used for landscape irrigation of all common areas.*
