Description of Nature, Purpose and Beneficiaries of Project:

Irvine Ranch Water District (IRWD) owns, operates and maintains a domestic water pipeline in Riparian View, adjacent to IRWD's Michelson Water Recycling Plant (MWRP) in the city of Irvine. MWRP receives domestic water from an existing sixinch asbestos cement pipe (ACP) located along the slope adjacent to Riparian View. In 2011, IRWD replaced a 600-foot segment of the pipeline with polyvinyl chloride pipe (PVC) from IRWD's Duck Club to an existing air gap facility within the MWRP. Since the end of 2017, the 600-foot segment has failed on several occasions. This project will replace the 600-foot PVC segment and slightly relocate the PVC pipeline within Riparian View.


