Reservoir project: an investment in our future

IRWD has a 60-year history of planning for the future needs of our District. That includes a new proposal to increase the capacity of one of our five reservoirs.

The Syphon Reservoir Improvement Project is an investment to increase the amount of recycled water that can be stored there to meet seasonal and future needs. This will reduce our dependence on costly imported water and make our community more self-sufficient.

Safety

Syphon Reservoir will be modernized and

upgraded to exceed the latest federal and state standards for design and safety.


Environmental review

The project is undergoing a thorough California Environmental Quality Act review process that includes opportunities for public input and stakeholder engagement.

Timeline

The environmental review process is expected to be completed by fall of 2021. IRWD will develop the preliminary and final design between spring 2021 and winter 2023. Construction could begin in

late winter 2023 and is estimated to take 2–3 years to complete.

IRWD participates in community partnerships to provide education about the importance of water and environmental sustainability. This includes Sea and Sage Audubon programs, community tours, and school programs such as water awareness poster contests, children's education festivals, and science fairs.

Q: I had a question about redoing my landscape. Are we still in planting season or do you recommend I wait?

A: We are fortunate to live in California where our climate allows us to plant year-round, but we must be careful. Since we are approaching mid-spring, it's still a good time to plant but be mindful that summer is right around the corner and it's getting warmer. The closer you

plant to summer the more you will have to water the new plantings so that they can establish. I would recommend you use mulch after planting as this will keep the soil cool, moist and allow the roots to develop. If you are removing grass as part of your project, consider participating in our turf removal program. Find out more at RightScape.com/rebates.

California native corner Juan's April plant: island alum root

Native to the Channel Islands, island alum root (Heuchera maxima) is a perennial herb that produces a rosette of large, round, purple-veined leaves and tall spikes of clustered bell-shaped pink or white flowers. Considered one of the most adaptable and vigorous of the alum roots, it grows best in part shade but can also bear full sun in coastal regions. Once established, it requires minimal water throughout year, especially in the summer. Learn more at CalScape.org and CalScape.org/planting-guide.php. — Juan
